#### September 17, 2024 Council Minutes-Amended

**Attendees:** Randy Baskerville. Dave Hill, Sarah Manro, Steve Middleton, Mary Jo Mikulski, Jeff Reising, Linc Schneider. Harold Seamon, Annette Lang

The meeting was called to order at 6:32 pm by Mary Jo Mikulski. Mary Jo opened with a devotion referring to the stewardship campaign theme of the gratitude factor.

The Minutes for the Council Meeting on August 20, 2024, were not approved.

Glenn Conn from Marilyn's Place came to speak on his concerns for lack of money and that Marilyn' Place may have to close. Glenn said the demands are increasing and the needs of the community are great. A grant would be useful to Marilyn's Place. Marilyn's Place is considered a mission of Bethel and Glenn is willing to provide the church with a list of items needed so it can be brought to the attention of the church. Holly is working on getting the electric bill paid for Marilyn's Place.

Proposed motion was made that missions will give Marilyn's Place \$1000.00 for expenses and the council will review how to move forward with helping Marlyin's Place.

Jeff Reising moved, and Randy Baskerville seconded, to approve the donation to Marilyn's Place. Motion passed unanimously.

# **Finance Report:**

• Revenue – Contributions in July totaled \$43,222. This is down compared to June which might be

expected since June was a "5 Sunday Month". Monthly contributions this year average \$50,307

• Expenses – Total expenses in July were down over \$6,000 compared to June. The decrease was due to lower utility expenses, lower property expenses, and no property insurance premiums due in July. Salary and Benefit costs were up in July because three payrolls were paid in July compared to two in a typical month.

• Revenue Minus Expenses – We had a \$5,192 deficit in the General Fund for the month of July. We now have a \$996 deficit through seven months.

• Designated Fund – Most of the changes we talked about for the designated fund at our council meeting last month have been made. The updates are still "a work in progress".

Steve Middleton proposed a motion to accept the treasures report, Randy Baskerville seconded the motion. Motion passed unanimously.

The next item discussed was the proposed budget for 2025. Because this involved a discussion of Pastor Dave's salary he volunteered to leave the meeting.

A proposed motion was made by Steve Middleton, for a proposed budget Pastor Dave's salary is increased by 3% in his compensation package.

Randy Baskerville seconded the motion. The motion passed. One council member abstained from voting.

#### Amendment to the motion regarding Pastor Dave's salary.

This amend occurred after it was discovered by a board member there was not a quorum. There was a quorum when the meeting took place. However, one member was attending virtually, and internet connection was lost during the time that the voting took place for an increase in Pastor Dave's salary. The discussion of Pastor Dave's salary will take place when a quorum is present. Please see the minutes on 10/15/2024, for the official vote on Pastor Dave's salary.

It was also decided that the \$150.00 allocated to Mutual Ministry should be left in the budget for 2025.

#### Council Budget Discussion 09/17/2024

- Budget Preparation Materials were sent out to council and staff members September 12 through September 15. The due date for return is October 6. Jim hopes a final council decision on the 2025 budget to present to the congregation can be made at the October meeting.
- 2. Revenue Comparison for Last 12 Months See chart on back.
- 3. Lead Pastor Compensation in 2025 Budget Last year we included compensation for a Lead Pastor in the budget for July through December, the total entered was \$11,279 per month. What is the council decision on what to plug in the budget for 2025? At the same rate plugging salary and benefits in for 12 months would be \$135,342. The exact amount cannot be known until a Pastor is called and we know what insurance plan he/she needs (family, member and spouse, single), tax status, what the Pastor negotiates, etc.
- 4. Staff Compensation and Benefits Will compensation stay the same or increase (raise)? In 2023 the staff received a 4% increase. There was no percentage increase for 2024. When Holly went back to hourly pay this August she got the equivalent of a 4.99 % raise. For reference, the SS COLA for 2024 was 3.2% and is estimated to be 2.5% for 2025. The Federal planning Bureau forecasts, average consumer price inflation should be 3.2% in 2024, compared to 4.06% in 2023 and 9.59% in 2022.
- Mutual Ministry Line item 5250 in the budget. Nothing expended from this account since at least 01/01/2020. Budgeted \$150 in 2024. Leave Mutual Ministry in the budget?

In addition, the missions committee paid for the other son's school expenses which totals \$500.00 for the year. The family now has all their passports, and they are planning on coming to America in August of 2025 for the convocation that will be held in Pittsburg, PA. The church in Ethiopia has been bombed once. The Pastor himself just happed to get off a bus that blew up after he got off at his stop. It is very volatile in Ethiopia.

More money is needed for the food pantry. Missions gave the food pantry \$20,000.00 in November of 2023 and they now have \$8.400.00 left. The church budget has \$10,000.00 allocated for the pantry this year.
