## NOTICE OF FEDERAL TAX LIENS

### IRS Fraud - Notice of Federal Tax Liens

Most of you have heard of the recent "WIN" in Oregon concerning the filing of a Notice of Federal Tax Lien.

CHECK THIS OUT: This is a recorded meeting of County Commissioners with citizen participation, held on 08-08-2007 in Douglas County Oregon. Rae Capitca explains how the IRS cons the county recorders into stamping and recording Notices of Federal Tax Liens, which are then enforced as if they are valid

liens. The IRS then uses the recorder's stamped copy of the recording as its only "evidence" of a lien. This is one of the many tools the IRS uses to steal millions of dollars from folks who do not engage in taxable activities. You are encouraged to compare your own state laws with those cited by Rae in the video, and bring these matters before your own board of commissioners. Your county recorders will think twice about recording these illegal pieces of paper as soon as enough of them find themselves in jail for securities fraud.

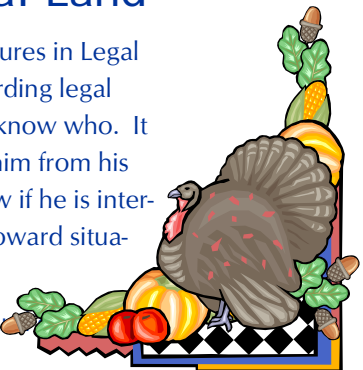

Our friend and fellow patriot, Eddie Kahn, has been indicted in Florida in conjunction with Wesley Snipes for FTF (Failure to File) and conspiracy to defraud the federal government.
