6 Q. Okay, she'll never hear this tape, so don't worry about it. Was anybody else in the vehicle  
7 with you at the time?

8 A. Yes, my girlfriend and her sister.

10 Q. And what's your girlfriend's name?

11 A. Rosemary.

14 A. Yeah.

16 Q. And her sister?

17 A. Annabelle.

14 A. No.

16 Q. Okay, that's okay, let's see, so as far as Samantha was concerned, she never complained of  
17 any injury, I take it?

18 A. No, not that I'm aware of.

19

20 Q. Okay, all right, and okay, can you just tell me briefly what happened in the accident?

21 A. Well, we were taking Annabelle to the movies, and we were pretty much just sitting at a  
22 stop light waiting to turn and we just got rear-ended.
