

RESOLUTION # 4-2011

A RESOLUTION authorizing the Common Council of the City of Batesville, Indiana, to amend Resolution No. 5-2010 that established the Batesville I-74 Area Economic Development Area as an economic development area.

WHEREAS, on May 10, 2010, this Council adopted Resolution No. 5-2010 regarding the establishment of the Batesville I-74 Area Economic Development Area; and

WHEREAS, on April 11, 2011, after notice and hearing as provided by the law, the City of Batesville ("City") Redevelopment Commission ("Commission"), did, adopt Amended Resolution 4-2010 finding that, after correcting scrivener's errors to the Resolutions No. 2-2010 and No. 4-2010, Exhibit A and Exhibit B are now complete and accurate descriptions of the parcels and legal description included in the Batesville I-74 Area Economic Development Area ("Area") established under IC 36-7-14 and IC 36-7-25, a copy of which is included by reference; and

WHEREAS, the Commission has requested the approval of the Common Council of the City of Batesville ("Common Council") for the amendment of the description of the Area;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BATESVILLE, INDIANA, THAT:

Section 1. The Common Council does hereby approve and adopt Amended Resolution 5-2010.

Section 2. All ordinances or resolutions and parts of ordinances or resolutions in conflict herewith are hereby repealed.

Section 3. If any sections, sentence or provision of this resolution, or the application thereof to any person or circumstances shall be declared invalid, such invalidity shall not affect any of the other sections, sentences, provisions, or application of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of the resolution are declared to be severable.

Section 4. This resolution shall be in full force and effect from and after its passage by the Common Council of the City of Batesville, Indiana and approval of the Mayor.
