**RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF BATESVILLE
AUTHORIZING THE SUBMITTAL OF THE MSRP APPLICATION
TO THE INDIANA OFFICE OF COMMUNITY & RURAL AFFAIRS
AND ADDRESSING RELATED MATTERS**

WHEREAS, the Council of the City of Batesville, Indiana recognizes the need to stimulate growth and to maintain a sound economy within its corporate limits; and

WHEREAS, The Housing and Community Development Acts of 1974, as amended, authorizes the Indiana Office of Community and Rural Affairs to provide grants to local units of government for the elimination and prevention of blight; and

WHEREAS, The City of Batesville, Indiana has a designated Main Street Program and this project is part of the Batesville Main Street's overall strategy; and

WHEREAS, the City of Batesville, Indiana, has conducted or will conduct public hearings prior to the submission of an application to the Indiana Office of Community and Rural Affairs, said public hearings to assess the housing, public facilities and economic needs of its low and moderate income residents;

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Batesville, Indiana, that:

1. The Mayor of the City of Batesville is authorized to prepare and submit an application for grant funding to address downtown revitalization specifically the renovation/rehabilitation of façades with in downtown Batesville and to execute and administer a resultant grant contract, including requisite general administration and project management contracts and agreements, pursuant to regulations of the Indiana Office of Community and Rural Affairs and the United States Department of Housing and Urban Development.
2. The City of Batesville, Indiana hereby commits requisite local funds in the amount of in the amount of *One Hundred Forty Two Thousand Six Hundred and Eighty Three Dollars and Forty-Seven Cents*, (\$142,683.47), in the form of cash from owners/tenants of the properties participating in the project (\$59,848.00), Ripley County Community Foundation (\$300.00), and the City of Batesville EDIT Tax Fund (\$69,700.00), for in the form of cash from the City of Batesville, as matching funds for said program, such commitment to be contingent upon receipt of MSRP funding from the Indiana Office of Community and Rural Affairs.
