1.0 SUBSCRIPTION AGREEMENT

1.2 The minimum subscription is \$500. The Company may accept or reject any subscription you tender, in whole or in part. When the Company sells its Minimum Subscription, the funds held in the Impound Account will be disbursed to the Company and stock certificates will be issued within five (5) business days. After that, you will be mailed stock certificates no more than five (5) business days after the Company mailed written confirmation of the subscription to you. If the Company accepts only part of your subscription, the Company will return the unused portion of your payment to you with interest, if any. If the Minimum Subscription is not sold prior to the Termination Date of the Offering, then all deposits will be returned to subscribers with interest earned, if any.
