Dear Parents, Family Members, Teachers and Other Professionals, and Community Members,

The new autism statistics are in. According to the CDC 1 in 110 (1 in 70 boys) are diagnosed with autism in the U.S. today. Of those families affected, 80 to 85% will be torn apart by divorce. When a family receives the diagnosis that their child has autism, it is devastating. Since mainstream medicine cannot agree on causes and treatments for autism, it can leave a family alone, without hope, and in the dark. However, there are options for families faced with the battle of fighting autism!

In April of 2008, at the age of 2 ½, our son Cole was diagnosed with autism. Since then, life has been a roller coaster ride: denial, diagnosis, more denial, anger, depression, prayer to God, and finally acceptance of the situation. We have spent countless hours praying, researching, and going to conferences. In January of 2009, we attended a bio-medical conference in South Bend, Indiana where we learned about bio-medical interventions. This was a turning point for our family! We have found hope by sharing stories with a community of families going through similar circumstances. Cole is now seeing a DAN! (Defeat Autism Now!) Doctor, and we are seeing slow but steady improvement. He has come a long way, and has a ways to go still. We pray for his recovery, and for an end to this disease.

Our goal is to eventually recover our son, but also we feel a definite responsibility to reach out to others. As a result of our experiences with our son, our family formed a ministry at our church called H3: Help, Hope, and Healing, Offering Support to Families Affected by Autism. H3 will be putting on an autism conference. We would like to extend to you an invitation to attend the H3 Autism Bio-medical and Alternative Therapies conference that will take place on March 20th, 2010 at Crosspointe Church of Christ in Franklin, Ohio, and we encourage you to bring teams of people in your child's life: grandparents, teachers, speech therapists, etc.

Come and hear parents' stories, listen to information from a DAN! (Defeat Autism Now!) Doctor, and learn from other professionals who are providing alternative approaches for treating kids with autism. It will be an incredible day of hope and learning!
