At the Farmington Town Board Meeting, held in the Town Hall or by Phone/Video Conferencing on the 13th day of April, 2021, at 7:00 PM, there were:

Supervisor Ingalsbe opened the public hearings at 7:00 p.m. The Town Clerk read the legal notice.

A LOCAL LAW AMENDING ARTICLE I (DOG CONTROL) AND II (DOG LICENSING) OF CHAPTER 49 OF THE FARMINGTON TOWN CODE, ENTITLED "ANIMALS"

Ms. Finley stated that the number of dogs that are allowed were added to the law. Mr. Delpriore added that the language was cleaned-up as well. Supervisor Ingalsbe asked if anyone wanted to speak for or against this proposed local law, hearing none, the public hearing was closed at 7:03 p.m.

A LOCAL LAW AMENDING CHAPTER 138 OF THE FARMINGTON TOWN CODE, ENTITLED "STORMWATER MANAGEMENT AND EROSION, AND SEDIMENT CONTROL"

Mr. Delpriore stated that language was cleaned-up with what the town adopted with their stormwater management plan. He added that they brought both documents up to a point of matching up to each other. Small changes here and there were made throughout the chapter but was more to make sure the terminology was the same for both documents. Supervisor Ingalsbe asked if anyone wanted to speak for or against the proposed local law, hearing none, the public hearing was closed at 7:04 p.m.

A LOCAL LAW AMENDING CHAPTER 140 OF THE FARMINGTON TOWN CODE, ENTITLED "STREETS AND SIDEWALKS"

Mr. Delpriore stated that he worked with the Highway Superintendent on cleaning up some of the language. He added that they also added trails in this section. He stated a lot of the terminology was updated. Supervisor Ingalsbe stated that the town doesn't want people parking at the end of the trails or on the sidewalks in their driveways. He added that there was no enforcement in the law so that was added. Supervisor Ingalsbe asked if anyone wanted to speak for or against the proposed law, hearing none, the public hearing was closed at 7:07 p.m.

A LOCAL LAW AMENDING CHAPTER 165 (ZONING) OF THE FARMINGTON TOWN CODE, SECTION 165-55 ENTITLED "KEEPING OF ANIMALS," SECTION 165-61 ENTITLED "FENCES," AND SECTION 165-76 ENTITLED "MOBILE HOMES AND MOBILE HOME PARKS"

Mr. Delpriore stated that Chapter 165 is Zoning and a lot of it they see goes to the ZBA to be handled by them and they receive a lot of questions when working with residents. He added that there are people who keep chickens and that was not defined that well where it should be in the code. Cleaned up definitions in that section.

The seconded section titled "Fences", Mr. Delpriore stated they get a lot of questions about it because they didn't understand the language of it so they updated the language of the chapter, goes over where they can be placed, discussed corner lots, and tells what a front yard and side yard is.

Mr. Delpriore stated that the last section titled "Mobile Homes and Mobile Home Parks" was a long section and needed a lot of updates and was overlooked for many years. He added that the biggest thing that changed in this section was that they went to an operating permit versus a special use permit. He added that the section does go into some of the zoning requirements as well. Mr. Krenichyn, 4880 Fox Road, asked if the mobile homes parks is referred to something already existing. Mr. Delpriore replied that there are three mobile home parks and mobile homes are classified that is something that has wheels and axels that are removed when placed on a permanent foundation where they then become a permanent structure, and there are rules and regulations that cover just that.

Supervisor Ingalsbe stated that the Board would like to drop the wording PD (Planned Development) from the section and just use the authorizing the RMF districts so the board will not be acting on this local law tonight and a new public hearing notice will be sent to the newspaper for the April 27, 2021, Town Board Meeting. The new law reflecting that change will be posted.

Supervisor Ingalsbe asked if anyone wanted to speak for or against this proposed local law, hearing none, the public hearing was closed at 7:13 p.m.

APPROVAL OF MINUTES:

A motion was made by **Councilman Casale** and seconded by **Councilman Holtz**, that the minutes of the March 23, 2021, Town Board Meeting, and given to members for review, be approved. All Voting "Aye" (Holtz, Casale, Herendeen, Bowerman, and Ingalsbe). Motion Carried.

PRIVILEDGE OF THE FLOOR: Jason Krenichyn – RV lot/Campers on corner of Fox Road and CR28

Mr. Krenichyn stated that he came to bring attention to the northwest corner of County Road 28 and Fox Road. He stated that for the last few years it has become increasingly expanding eye sore to those who drive by it daily, there is no residence just a vacant lot that becomes a miniature seasonal RV park in April and vacated in October/November. He stated that in years past campers come and go but last year one did stay permanently towards the north end of the property. He stated that currently a few non-permanent structures and another was erected this past weekend. He added that he usually gets calls or text from neighbors and friends regarding this issue and one even jokingly referred to it as a gypsy camp. He added that last year there were several weekends where there were major gatherings, and this would seem okay in some places, but this happens to be on the corner of a 55 mph reasonably busy throughfare and all not too long ago there were three major accidents in a three month stretch at this intersection. He added that he was home for all three of them and helped pull people out and this was without any camping on the corner. He fears that when there are three, four, or five pull ahead campers then another dozen or so cars on this corner that the danger level of the intersection will become exponential. Mr. Krenichyn stated that even though Mr. Holtz and Mr. Ingalsbe live in neighborhoods, but he implores them to imagine two or three campers showing up between your house and the neighbors, it wouldn't seem to belong there. He then said to Mr. Casale that he has open land to his west and invites him to look at the same. He then directed to Mr. Bowerman and Mr. Herendeen who have farmland borders them respectively and if they could imagine seasonal campers next to their homes, which at times seems like a travelling circus. He certainly understands that there are people who enjoy living in a camper for 6 or 7 months but there are places for that, there are seasonal RV parks and camp parks exactly for that. He added that when you drive down Fox Road it's decent house, decent house, decent house, then it is RV campers, canvas car ports, storage trailers, campers circled around a fire pit with 220 lines running all over the place so more campers can come hook up on the weekends. He stated that he didn't necessarily build his house in the middle of the country to have something like that pop up next door to him. He implored the Board to put themselves in his situation and to drive by sometime and look and see if they would like that next to them.

Supervisor Ingalsbe stated that he did look that lot up on GIS and the lot is about an acre in size. Mr. Delpriore stated that he had his staff look into this and that this has been an ongoing investigation for them. First Mr. Delpriore gave the definition of what a campground is per town code. He stated that a campground is a facility that is leased for rented spots out to people to gather for the placement of tents, travel trailers, RV's, and vehicles like that that are registered and regulated by the Department of Motor Vehicles. Mr. Delpriore stated that when they talked with the owner of the property, the owner stated that he does not receive money and that it is friends that are gathering and there is no code against that. Mr. Delpriore gave a brief history of the property and stated that there was a structure there that burned down in September 1993, a few years ago the current owner started putting a camper on the site where the house was so there is utilities that are existing. The owner stated that it was just friends and family that visit during the summer, he feels that he owns that land and within code he isn't doing anything that isn't allowed. Mr. Delpriore stated that he respects Mr. Krenichyn's comments but if the town regulates what this owner is doing it would say that Mr. Krenichyn couldn't have any friends or family at your property. Mr. Delpriore stated that they are keeping an eye on the property, the structures that are temporary on the property they are looking into because they are not up to code, but as far as the RV's that are on the property and as long as they are registered and not mounted then this is an allowed use. Mr. Delpriore added that in 2019 the owner requested a second driveway onto to Fox Road, but it was denied by the Highway Superintendent and Code Enforcement. Mr. Delpriore stated that if there is ever any money being exchanged then his office would need to know that because then if falls into a different category of the code. Mr. Delpriore stated that his office has received noise complaints but the Town does not have a noise ordinance so they can't enforce anything. Mr. Krenichyn stated that the noise complaints did not come from him. Supervisor Ingalsbe thanked Mr. Krenichyn for bringing this to their attention and they will keep an eye on the property.

WHEREAS, the Town Board has conducted a public hearing on the proposed amendments to Articles I and II of Chapter 49 of the Farmington Town Code; and

WHEREAS, the Town Board has given consideration to the public hearing record held upon the proposed amendments contained within the Final Draft of Local Law No. 7 of 2021.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board does hereby adopt in its entirety the above referenced Final Draft Local Law (Local Law No. 7 of 2021) dated March 23, 2021.

BE IT FINALLY RESOLVED, that the Town Clerk is to provide a Certified Copies of this resolution and the adopted Local Law to the New York State Secretary of State for filing in that Office.

BE IT FURTHER RESOLVED, that the Town Clerk upon receipt from the State Secretary of State Office is to submit a copy of the filed local law to General Code Publishers requesting Chapter 49 be amended and that copies thereof be provided to the Town for inserting in the Town Code Book.

BE IT FINALLY RESOLVED, that copies of this resolution be provided to: the Town Code Enforcement Officer; and the Town Director of Planning and Development.

Local Law No. 7 of the year 2021

"Amendments to Part II, General Legislation, Chapter 49, Article I, Sections 49-1 through 49-7, of the Farmington Town Code, entitled Dog Control; and Chapter 49, Article II, Section 49-8 through 49-18, entitled Dog Licensing."

Be it enacted by the **Town Board**

Town of Farmington

as follows:

Section 1. Title. Article I, Chapter 49 of the Town of Farmington Code, entitled Animals is hereby amended as follows:

§ 49-1. Title.

Article I, Chapter 49, of the Town of Farmington Code shall be known and may be cited as the "Dog Control Law of the Town of Farmington."

§ 49-2. Purpose.

This Section shall continue as § 49-2 of the Town of Farmington Code.

§ 49-3. Definitions.

The following terms are hereby defined and added to, in alphabetical order, this subsection of Article I, Chapter 49, Section 3 of the Town of Farmington Town Code.

(1)

DOG CONTROL OFFICER - Means any individual appointed by the Town Board to assist in the enforcement of this Article or any authorized officer, agent or employee of an incorporated humane society or similar incorporated dog protective association under contract with the Town of Farmington to assist in the enforcement of this article.

DANGEROUS DOG – means any dog which (i) without justification attacks a person, companion animal as defined in Article 7 of the Agriculture and Markers Law, subdivision five of section three hundred fifty, farm animal as defined in subdivision four of section three hundred fifty, or domestic animal as defined in subdivision seven and causes physical injury or death, or (ii) behaves in a manner which a reasonable person would believe poses a serious and unjustified imminent threat of serious physical injury or death to one or more persons, companion animals, farm animals or domestic animals or (iii) without justification attacks a service dog, guide dog or hearing dog and causes physical injury or death.

DOG SHOW – An event or exhibition in which a judge, familiar with a specific dog breed, evaluates individual purebred dogs for how well the dogs conform to the established breed type for their breed, as described in a breed's individual breed standard.

§ 49-4. Restrictions.

The following subsection D. is hereby added.

§ 49-4. D. It shall be unlawful to keep four (4) or more dogs that are four (4) months of age or older on any premises, regardless of the number of owners, unless the provisions of the Zoning Law of the Town of Farmington, Chapter 165 of the Code of the Town of Farmington and the laws of the State of New York in regard to kennels are complied with.

§ 49-5. Prohibited Acts.

This subsection is hereby created and shall read in its' entirety as follows:

§ 49-5. Prohibited Acts.

- A. No dog shall engage in loud howling or barking or conduct itself in such a manner as to annoy any reasonable person.
- B. No dog shall cause damage to or destruction of property or commit a nuisance.
- C. No dog shall bite, chase, or otherwise harass any person or other animal in such a manner as reasonably cause intimidation or puts such person in reasonable apprehension of bodily harm or injury.

§ 49-6. Complaints and Dangerous Dogs.

This subsection is hereby created and shall read in its' entirety as follows:

§ 49-6. Complaints and Dangerous Dogs.

Any person who observes a dog committing a prohibited act listed in § 49-5 above herein, or as defined in Article 7, section 123, of the New York State Agriculture and Markets Law, may file a signed complaint, made under oath, with: the Town Code Enforcement Officer or an Assistant Town Code Enforcement Officer; or the Town Zoning Officer; or the Town Clerk or Deputy Town Clerk specifying the objectionable conduct of the dog, the date of such conduct, the nature of the event, any damage caused, a description of the dog, and the name and residence, if known, of the owner or person harboring said dog. The Town Official receiving the complaint shall immediately deliver the complaint to the Town of Farmington Town Justice Court in accordance with the provisions contained within § 49-7 below of this Chapter.

§ 49-7. Enforcement; penalties for offenses.

This is a re-numbered subsection of Part II, General Legislation, Chapter 49, Article I of the Farmington Town Code, formerly identified as § 49-5 Enforcement; penalties for offenses. The former provisions of § 49-5 are hereby repealed in their entirety and a new § 49-7 is hereby created and shall read in its' entirety, as follows:

§ 49-7. Enforcement; penalties for offenses.

- A. Enforcement Officers. The provisions of this Chapter may be enforced by any person, the Town of Farmington, or organization for the prevention of cruelty to animals, appointed by law, or pursuant to, a contract in effect with the Town of Farmington.
- B. Appearance Tickets and Process. Any person who is a member of an organization authorized to enforce the provisions of this Chapter may issue an appearance ticket for an alleged violation hereof, pursuant to section 150.20 of the New York State Criminal Procedure Law. In addition, an appearance ticket may also be issued for any alleged violation of Article 7, section 118 of the Agriculture and Markets Law of the State of New York. Said person is hereby authorized to serve any process relating to any proceeding, whether civil or criminal in nature, in accordance with the provisions of this Chapter. In the event an appearance ticket is unanswered, the Town of Farmington Town Justice Court shall permit filing of an information from the appropriate enforcement person and issue a warrant of arrest for the alleged violator.
- C. Seizure. Any dog found to be at large by the dog control officer in the Town of Farmington shall be seized, and properly fed and cared for by the Ontario County Humane Society until redeemed or disposed of in accordance with the provisions with the provisions of article 7, section 117 of the Agriculture and Markets Law of the State of New York. The owner of the dog, upon presentation of a valid dog license and upon payment of the impoundment fees established by the aforesaid Article 7, section 117 of the Agriculture and Markets Law of the State of New York may redeem such dog. In the event a dog is not redeemed within the statutory time period, an owner forfeits title to said dog, which shall then be made available for adoption or euthanized in accordance with Article 7, section 117 of the Agriculture and Markets Law of the State of New York. The seizure of any dog shall not relieve any person of prosecution for violation of the provisions of this Chapter.
- D. Commencement of Proceedings. Any person alleged to be found to have permitted any dog to be at large in the Town of Farmington shall be issued an appearance ticket for an alleged violation of this Chapter and shall be prosecuted in the manner provided for herein.
- E. Penalties of Violations. Pursuant to section 80.05 of the Penal Law of the State of New York, a violation of the provisions of this Chapter shall be punishable by a fine of not more than \$250.00.

Section 2. Article II Dog Licensing.

The following amendments are hereby made to Part II, General Legislation, Chapter 49, Article II, Sections 49-6 through 49-18 of the Farmington Town Code.

§ 49-6. Title.

This section of the Town of Farmington Town Code is hereby deleted and replaced in its' entirety to read:

§ 49-8. Title.

Article II, of Chapter 49 of the Town of Farmington Town Code, shall be known and may be cited as "Dog Licensing Law of the Town of Farmington Town Code."

§ 49-7. Licensing of dogs.

This section of Chapter 49 is hereby deleted and replaced in its' entirety to read as follows:

§ 49-9. Licensing of Dogs.

All dogs being harbored in the Town of Farmington, unless otherwise exempted by the provisions contained in Article 7, section 109, of the New York State Agriculture and Markets Law, must be licensed by the age of four months with the Town Clerk of the Town of Farmington.

§ 49-10. Application.

This section of Chapter 49 is hereby deleted and replaced in its' entirety to read as follows:

§ 49-10. Application.

The owner of each dog required to be licensed, by the provisions of this Chapter of the Town of Farmington Town Code, shall obtain a dog license application form that is to be completed and returned, along with the items contained below herein, to the Farmington Town Clerk for issuing of a dog license:

- A. A dog license application form.
- B. The license application fee and any additional fees as established by the Town Board as part of the adopted of the Town of Farmington Annual Fee Schedule.
- C. Any applicable license surcharges.
- D. Proof that the dog has been vaccinated against rabies or a statement from a licensed veterinarian that such vaccination would endanger the dog's life, in which case vaccination would not be required.
- E. In the case of a spayed or neutered dog, a certificate by a licensed veterinarian or an affidavit signed by the owner of the dog showing that the dog has been spayed or neutered, provided such certificate or affidavit shall not be required if the same is already on file with the Farmington Town Clerk's Office. In lieu of the spay or neuter certificate, an owner may present a statement certified by a licensed veterinarian stating the he or she has examined the dog and found that, because of old age or other reason, the life of the dog would be endangered by spaying or neutering. In such case, the license fee for the dog shall be the same as for a spayed or neutered dog.

§ 49-9. Identification tag.

This section of Chapter 49 is hereby deleted and replaced in its entirety to read as follows.

§ 49-11. Identification tag.

Each dog licensed pursuant to this article shall be assigned, at the time the dog is first licensed, a municipal identification number. Such identification number shall be carried by the dog on an identification tag which shall always be affixed to a collar on the dog. No tag carrying an identification number shall be affixed to the collar of any dog other than the one to which that number has been assigned.

§ 49-12. License term.

Chapter 49, Section 10 is hereby deleted in its' entirety and is hereby replaced by a § 49-12. License term, which is to read in its' entirety as § 49-12, as follows:

§ 49-12. License term.

All dog licenses will be issued for a period of up to three years and said license will expire on the last day of the last month of the period for which they are issued.

§ 49-11. License nontransferable.

Chapter 49, Section 11. License nontransferable is hereby deleted in its' entirety and is replaced by § 49-13. License nontransferable which is to read, in its' entirety as § 49-13. License nontransferable., as follows:

§ 49-13. License nontransferable.

Any license issued pursuant to this Article, shall not be transferrable. Upon the transfer of ownership, or new address of any dog within the Town of Farmington, the new owner shall immediately make application for a new license for such dog.

§ 49-12. Purebred License.

Chapter 49, Section 12. Purebred License is hereby deleted in its' entirety and is replaced by § 49-14. Purebred License. Which is to read, in its' entirety, as follows:

§ 49-14. Purebred License.

The Town of Farmington will issue purebred licenses but will not issue separate purebred tags.

§ 49-13. Guide dog, service dog, hearing dog or detection dog tag.

Chapter 49, Section 13. Guide dog, service dog, hearing dog or detection dog tag is hereby deleted in its' entirety and replaced with § 49-15. Guide dog, service dog, hearing dog or dog tag. Which is to read, in its' entirety, as follows:

§ 49-15. Guide dog, service dog, hearing dog or detection dog tag.

The Town of Farmington will not issue a special tag for identifying any guide dog, service dog, hearing dog or detection dog tag.

§ 49-14. Fees and surcharges.

Chapter 49, Section 14. Fees and surcharges is hereby deleted in its' entirety and replace with § 49-16. Fees and surcharges. Which is to read, in its' entirety, as follows:

§ 49-16. Fees and surcharges.

The fees and surcharges for issuing dog licenses shall be fixed by the Town Board as part of the Town of Farmington's Annual Fee Schedule and by the provisions contained in Article 7, section 110, of the New York State Agriculture and Markets Law. Such Ton fees and surcharges may, from time to time, be changed as the Town Board may determine. These fees and surcharges include:

- A. The license fee for a spayed or neutered dog.
- B. The license fee for an unsprayed or an unneutered dog (such Town fee having to exceed the fee for a license for a spayed or neutered dog by such amount as mandated in Article 7, Section 110, of the New York State Agriculture and Markets Law);
- C. In addition to the license fee authorized by this Chapter and established by the Town Board of the Town of Farmington and contained in the Annual Fee Schedule, a surcharge for the issuance of a purebred license (such surcharge shall be, at a minimum, such amount as mandated by Article 7, Section 110, of the New York State Agriculture and Markets Law) for the purposes of carrying out animal population control efforts
- D. In addition to the license fee authorized by this Chapter and established by the Town Board of the Town of Farmington as part of the Annual Fee Schedule, a surcharge is hereby authorized if the dog to be licensed is altered (such surcharge shall be, at a minimum, the amount specified in Article 7, Section 110, of the New York State Agriculture and Markets Law).
- E. In addition to the license fee authorized by this Chapter and established by the Town Board of the Town of Farmington as part of the Annual Fee Schedule, a surcharge is hereby authorized if the dog to be licensed is not altered (such surcharge shall be, at a minimum, the amount specified in Article 7, Section 110, of the New York State Agriculture and Markets Law).
- F. In addition to the license fee authorized by this article and established by the Town Board of the Town of Farmington as part of the Annual Fee Schedule, a surcharge is hereby authorized to recover and defray the cost of an enumeration of dogs living with the Town of Farmington.
- G. In addition to the license fee authorized by this Article and established by the Town Board as part of the Annual Fee schedule, a surcharge is authorized for offsetting costs associated with the provision and replacement of identification tags.

\S 49-15 Exemptions.

Chapter 49, Section 15. Exemptions. Is hereby deleted in its' entirety and replaced with § 49-17. Exemptions. Which is to read, in its' entirety, as follows:

§ 49-17. Exemptions.

- A. Exempted from payment of the license fees are applications submitted for a dog license for any of the following dogs, provided written documentation is provided with such application that certifies such dog as being any of the following:
 - 1. Guide dog.
 - 2. Hearing dog.
 - 3. Service dog.
 - 4. War dog.
 - 5. Working search dog.
 - 6. Detection dog.
 - 7. Police work dog.
 - 8. Therapy dog.
- B. At the time the Town Board establishes the license fees authorized pursuant to § 49-16 of this Article, the Town Board may permit a partial or full exemption to senior citizens, for the dog license fees fixed by the Town Board and made part of the Town's Annual Fee Schedule.
- C. A dog participating in a dog show within the Town of Farmington shall be exempt from wearing its' identification tag while participating in the event.

§ 49-15. Penalties for offenses.

Chapter 49, Section 16. Penalties for offenses. Is hereby deleted in its' entirety and replaced with § 49-18. Penalties for offenses. Which is to read, in its' entirety, as follows:

§ 49-18. Penalties for offenses.

A violation of this article shall be punishable by:

A. A fine of \$25.00 for a first violation.

- B. A fine of \$50.00 for a second violation.
- C. Where the person is found to have committed two or more such violations within the preceding five years, either a fine of \$100.00; or imprisonment for not more than 15 days, or both.

Section 3. If any clause, sentence, paragraph, section or part of this local law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which such judgment shall have been ordered.

Section 12. This local law shall take effect immediately upon filing with the Secretary of State of the State of New York.

\S 138-2. STORMWATER MANAGEMENT PROGRAM PLAN (SWMP PLAN)

A plan document based upon guidelines accepted by the New York State Department of Environmental Conservation (NYSDEC), prepared by the Town's Engineers and Town Staff, which has been publicly reviewed and formally adopted by the Town Board in an ongoing effort to reduce the illicit discharge of pollutants into the ground waters of the Town of Farmington and the State of New York to the maximum extent possible. The document is a living guide to achieve each of the six minimum control measures (MCMs) as required by the NYSDEC which is subject further to amendment based upon new information provided by the

NYSDEC. The document, upon adoption, is made part of the latest edition of the Town of Farmington Comprehensive Plan and shall remain as part of said Plan.

§ 138-7. A. Stormwater pollution prevention plans (SWPPP).

Chapter 138-7. A. of the Town of Farmington Town Code is hereby deleted and replaced in its' entirety to read:

§138.7.A. Stormwater pollution prevention plan requirement. No application for approval of a land development activity shall be reviewed until the appropriate board has received a stormwater pollution prevention plan (SWPPP) prepared in accordance with specifications in this Chapter and the latest adopted edition of the Town of Farmington Stormwater Management Program Plan (SWMP Plan).

§ 138-8. C. Performance and design criteria.

Chapter 138-8. C. of the Town of Farmington Town Code is hereby deleted and replaced in its' entirety to read:

§138.7.C. Shall meet all standards contained in the latest adopted edition of the Town of Farmington Stormwater Management Program Plan (SWMP Plan).

§ 138-10. Maintenance and repair of stormwater facilities.

Chapter 138-10 of the Town of Farmington Town Code is hereby amended by adding the following subsection F. to read in its' entirety as follows:

§138-10 F. Shall meet all standards contained in the latest adopted edition of the Town of Farmington Stormwater Management Program Plan (SWMP Plan).

§ 138-11. Administration and enforcement.

Chapter 138-11 of the Town of Farmington Town Code is hereby amended by adding the following subsection 11.A.6. Construction Inspection.

§138-11. A. 6. Shall meet all standards contained in the latest adopted edition of the Town of Farmington Stormwater Management Program Plan (SWMP Plan).

Section 2. If any clause, sentence, paragraph, section or part of this local law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which such judgment shall have been ordered.

§ 140-3. Permit fee.

Article I. Highway Excavation, Chapter 140, Section 3. Permit Fee. of the Town of Farmington Town Code is hereby deleted and replaced in its' entirety to read:

§140-3. Permit fee.

The applicant for a highway excavation permit specified above in §140-2 of this Chapter shall pay a fee to the Town Clerk prior to the issuance of such permit. Said fee shall be that which is made part of the annually adopted Town of Farmington Fee Schedule.

§ 140-4. Bond required.

Article I. Highway Excavation, Chapter 140, Sections 4., 5., 6. and 7. Of the Town of Farmington Town Code is hereby deleted and replaced in their entirety to read as follows:

§ 140-4. Bond required.

No highway excavation permit shall be issued until the applicant has provided the Town Clerk with:

- A. A performance bond or other acceptable form of surety, in the amount determined by the Town Highway Superintendent and accepted by the Town Board, to be sufficient for assuring the Town that its' highway and the improvements therein, or adjacent thereto, and belonging to the Town, or which is determined to be in the best interest of the Town, will be restored to the condition in which they were found immediately prior to the excavating, drilling ro boring for which such permit is issued. In the event the applicant shall disagree with the Highway Superintendent's determination of the amount of the performance bond or other acceptable form of surety, the applicant may appeal this matter to the Town Board. The Town Board, by resolution, shall fix the amount of such performance bond or other acceptable form of surety. No permit shall be issued by the Town Highway Superintendent until an acceptable amount has been filed with the Town Clerk's Office.
- B. A Certificate of Insurance coverage showing the applicant has coverage in the amounts acceptable to the Town's Insurance Company.

§ 140-5. Waiver of bond.

No performance bond or other acceptable form of surety, shall be required for the issuance of a Town Highway Excavation Permit to excavate, drill or bore within the right-of-way boundary of any state or county highway. The Town Highway Superintendent shall clearly state upon such permit that no Town improvements are located within or adjacent to the area which is within the right-of-way boundary of any county, or state highway.

§ 140-6. Completion of work.

Such Town Permits shall be valid only during the period of time specified thereon, as determine by the Town Highway Superintendent. At the expiration of such period, or as may the work be completed sooner, and the expiration of five business days thereafter, the Town Highway Superintendent shall mail a notice to the applicant specifying the work performed has been accepted; and the property affected has been restored to the condition in which they were found. In the event the work is found not to be performed in accordance with the specifications contained in the permit and/or the property has not been restored to the condition in which it was originally found, the Town Board by resolution, shall then cause such work to be performed, applying the necessary amount in the performance bond or other acceptable for of surety to the timely completion of the work and/or the restoration of the property to its condition in which it was found. The

provisions of this section shall not limit the rights of the Town to bring any other legal action against the applicant, his agents or employees, to recover additional costs incurred by the Town.

- § 140-9. Notice required prior to civil actions. Is hereby renumbered §140-10 and shall read in its' entirety as currently stated in § 140-9 of Chapter 149 of the Farmington Town Code.
- § 140-10. Defective sidewalks; presence of snow or ice. Is hereby renumbered § 140-11 and shall read in its' entirety as currently stated in § 140-10 of the Farmington Town Code.
- § 140-11. Transfer of notices to Clerk. Is hereby renumbered § 140-12 and shall read in its' entirety as currently stated in § 140-11 of the Farmington Town Code.

Supervisor Ingalsbe stated that Mr. Newton has consistently for the past three years complain about the weight and speed limit on County Road 41 and that if he had it his way he would put weight limits and reduce the speed, Supervisor Ingalsbe has consistent in telling him that County Roads are for heavier traffic and that they don't want them on the town roads. Supervisor Ingalsbe stated that Mr., Newton contacted the County, Christopher Day, Department of Public Works, and pled his case there and Mr. Day contact Peter to give

him the heads up. Mr. Day told the Supervisor that he had said the same thing to Mr. Newton. Supervisor Ingalsbe stated that he heard from Mr. Newton a few days later and told him that the town was not going to change the weight limit or speed limit and that he certainly can do a petition and submit that to the town to go through proper channels. Councilman Holtz added that the town has increased patrol in that area and the speed limit is 40 mph. Supervisor Ingalsbe stated that he even asked for more patrol in that area specifically for speeders and they have flashing speed limit signs that they move around town.
