WHEREAS, the assessor and the attorney handling assessment litigation for the Town have obtained discovery, worked with an appraiser from Ontario County to analyze Petitioner's claims, reviewed sales of comparable properties and Petitioner's income and expense information, evaluated the cost of obtaining a formal appraisal, considered Petitioner's willingness to discontinue prior actions, evaluated the impact of the equalization rate on the value, assessed the cost and risks of litigation and, based on this information, the Town Board has determined that a settlement of these actions is in the best interest of the Town; and
