ADVERTISEMENT FOR BIDS

In accordance with Section 103 of Article 5-A of the General Municipal Law, sealed Bids for the construction of the Canandaigua-Farmington Town Line Road Culvert Replacement will be received by Town of Farmington, at the office of the Town of Farmington, 1000 County Road 8, Farmington, New York 14425, until **10:00 AM** local time on **April 10, 2019**, at which time the Bids received will be publicly opened and read.

The project involves assisting the Town of Farmington and Town of Canandaigua with the replacement of an existing culvert below Canandaigua-Farmington Townline Road. The contractor's responsibilities will include the installation of a temporary coffer dam, a bypass pumping system or flow bypass, selective demolition, installation of watermain across the stream, subbase preparation and installation of a four sided precast concrete culvert, installation of precast concrete wing walls, backfill up to defined elevations, and restoration of the stream bed.

Sealed Bids will be received for a single prime Contract. Bids shall be on a lump sum basis.

A Pre-Bid Conference will not be held.

The Town of Farmington, Ontario County, New York, reserves the right to reject any or all bids, or to waive any informalities, or to make an award to other than the low bidder. It further reserves the right to limit the amount of the award. Attention of the bidders is particularly directed to the requirements of the conditions of employment to be observed and minimum Wage Rates to be paid under the Contract.

Bid security shall be furnished in accordance with the Instructions to Bidders.
