

**Town of Farmington**  
**Dog Control Complaint**

This complaint must be filed with the Town Code Enforcement Officer, the Town Clerk or a deputy Town Clerk of the Town of Farmington who will then forward the same to the Farmington Town Court in accordance with Chapter 49 of the Code of the Town of Farmington.

**ALL COMPLAINTS MUST BE NOTARIZED PRIOR TO BEING FORWARDED TO THE COURT**

**§49-4 Prohibited Acts:**

- (a) Engage in loud howling or barking or conduct itself in such a manner so as to annoy any reasonable person other than the owner or person harboring such dog.
- (b) Cause damage or destruction to property, or commit a nuisance upon the premise of a person other than the owner or person harboring such dog.
- (c) Bite, chase or otherwise harass any person in such a manner as reasonably causes intimidation or puts such person in reasonable apprehension of bodily harm or injury.

**§49-5 Complaints:**

**Section 1.** Any person who observes a dog committing a prohibited act listed in §49-4, as amended, may file a signed complaint under oath with the Town Code Enforcement Officer, the Town Clerk or a deputy Town Clerk of the Town of Farmington specifying the objectionable conduct of the dog, the date thereof, the damage caused, if applicable, a description of the dog and the name and residence, if known, of the owner or person harboring said dog. The Town Officer taking the complaint shall immediately deliver the complaint to the Town of Farmington Justice in accordance with §49-6 of this chapter.
