**Hello Residents**, welcome to 2024. We have closed the financial books for 2023 and Parkland fees, Sales tax and building fees came in higher than projected. Mortgage tax and sewer/water district revenues were lower than budgeted for 2023. Overall, our departments have updated some of their vehicles and our Town roads are well maintained by our highway department. We have reserves set aside for future projects or unanticipated emergencies. For 2024 we lowered the Town General & Highway tax rate and because of higher water expenses that tax rate is up.

**Communicating with you:** We have budgeted for an additional newsletter in 2024, we try to keep our website and Town Facebook page up to date, and all our Town Board, Planning Board and Zoning Board of Appeals meetings are available on ZOOM the evening of the meeting or you can view meetings on U-Tube when you have time. Later in this newsletter we are announcing a Parks & Recreation Survey. We would like all residents to participate. There will be a few questions on Boughton Park membership, a future Town Park and would you support a joint effort with the Town of Victor for a Recreation Center.

**New Projects:** Later in this newsletter we have added information on some of the newer projects in the planning process. We still see interest in housing and commercial projects, so keep in touch with our reports listed in our website that are updated twice a month. **Environmental Information:** We still have a few compost containers available at \$25.00 each, we will have a rain barrel event this spring and we have two cleanup weekends planned for 2024. Farmington is sponsoring along with Ontario County two events. One is an electronics waste collection event tentatively scheduled for May 18<sup>th</sup> and a tire collection event for September 7<sup>th</sup>, 2024, both will be located at our highway garage. Look for information on how to register on our website, the Ontario County website, or the Daily Messenger.

**Surplus File Cabinets:** We have 20 surplus 4 drawer file cabinets that residents can purchase for just \$10.00 each. They are in good shape available at the Town Hall after paying the Town Clerk office. First come first served.

**County Road 8 Paving:** Ontario County has scheduled a mill & fill paving project for County Road 8 north of NYS Route 96 to the Wayne County Line. This includes the Town Hall/Town Park area so watch our Town website and Town Facebook page for when they get closer to the start date.

# From the Desk of the Town Clerk

**DOG LICENSES** - Article 7 of the New York State Agriculture and Market Law requires all dogs older than 4 months old to be licensed within the town they reside. Licensing ensures that all dogs have been properly vaccinated against rabies for the protection of both you and your neighbors. Any dog living with you for more than 30 days must be licensed.

## **Requirements:**

- 1. Puppies by four (4) months of age, rabies shots must be administered by three (3) months of age
- 2. Older dogs within ten (10) days of adoption.
- 3. Report status changes in writing within ten (10) days.
- 4. Maximum of three **(3)** dogs per property in the Town of Farmington, without obtaining a variance.
- 5. Citizens over 65 years of age are eligible for a senior discount on the dog license.
- 6. Multiple year (1, 2, & 3 year) dog licensing is available; we cannot exceed the rabies vaccination expiration date.

There is no application needed prior to licensing a dog, just bring proof of rabies and if the dog has been spaded or neutered to the Town Clerks Office.

**Ontario County Humane Society**, 585-396-4590, handles stray dogs, dog bites, and inhumane animal treatment reports.

**Nuisance problems** with neighbor's dogs, which cannot be settled between the neighbors, are handled through the Town Court. Complete a deposition (available at the Town Hall).

Clinics are Free but donations are appreciated. Animals must be healthy and at least 3 months old. Pets must be on a leash or in a carrier, one pet per carrier. No more than four pets per person. Please bring your animals past rabies certificate, if any. The link to preregister your pets will be shared on the Ontario County Public Health website a few weeks before each clinic date. Any questions should be directed to Ontario Count Public Health at 585-396-4343.

## PARK RESERVATIONS

The Town of Farmington has five parks with pavilions and one with a lodge. Farmbrook Park is located within the Farmbrook Subdivision, Farmington Grove Park is located within the Mountain Ash Drive Subdivision, the Town Park is located at the corners of Collett Road and County Road 8, Pumpkin Hook Park is located on Allen-Padgham Road and the newest park is Beaver Creek Park located within the Auburn Meadows Subdivision. Mertensia Park is located on Mertensia Road. Reservations can be made starting the first business day in January for Farmington residents only, beginning the first business day in February all others can make reservations. The renter must be 21 years of age. The rental fee for the parks with just pavilions is \$25.00 resident, \$35.00 non-resident, business/company in town is \$35.00, out of town is \$80.00. The rental fee for the Mertensia Lodge is \$150.00 for Farmington residents and \$250.00 for all others. There is also a \$100.00 key/cleanup deposit that is refundable as long as all policies and procedures are followed. Cancellations must be put in writing stating the following: the current date, the date of the reservation, state the reason for the cancellation, and signed by the person who signed the contract. The Town retains a 20% cancellation fee. The lodge has a 98-person capacity. There is no alcohol or smoking permitted. Payment for Mertensia Park Lodge reservations must be paid within five (5) business days. All other parks payment is due two (2) weeks from the date the reservation was made.

The Environmental Conservation Board (ECB) meets on the fourth Monday of the month at 7pm at the Town Hall.

## Planning & Development Ronald Brand, Director of Development

Redfield Grove Incentive Zoning, Section 3, Commercial Project. The Town Planning Board, at their meeting on Wednesday, January 17, 2024, approved with conditions the application for the Preliminary Re-subdivision Plat of the five original lots located within Section 3 of the above referenced project. Below is a concept of how these five lots could be developed in the future. There are no changes proposed to the types of land use originally approved by the Town Board in 2015. The proposed re-subdivision reduces the number of proposed lots along Commercial Drive from five to four. The change provides additional inter-connecting access points for these four lots, additional on-site parking within the front portions only for each of the remaining lots along Commercial Drive, a reduction in the number of curb cuts to Commercial Drive and a small vest pocket park to be located within a portion of the most northern lot that is to be maintained by the owner. The fifth lot is located along the north side of State Route 96. In 2015, this lot was to be combined with the original Lot #1 and would have provided a second driveway to the lot from State Route 96. It has now been approved for a small office-type use with limited on-site parking of seven vehicles.

### Other new applications underway in 2024....

Blackwatch Office Park Amended Final Site Plan for Flex Space Building - North side of County Road 41, west of County Road 8.

Paddock Landing Incentive Zoning Project - 186 single family lots and mixed limited Industrial and commercial use along Route 96. North side of State Route 96, between Glen Carlyn Drive and County Road 8.

Whitestone Incentive Zoning Project Mixed commercial, limited industrial and single-family dwellings. -East of Route 332, south of County Road 41 and west of Quentonshire Drive (Former "Glacier Lakes Water Park Project").

Farmbrook Site Plan Applications, Sections 7A & 7B - The Planning Board, at their meeting on Wednesday, January 17, 2024, granted preliminary site plan approval with conditions for a total of seventy (70) single-family dwellings to be constructed upon lots located within Sections 7A and 7B of the Farmbrook Planned Subdivision Project. This project is located in the southeast corner of the Farmbrook Planned Subdivision District and it includes construction of Alfalfa Crescent, connection of Oatfield Drive with Meadowbrook Lane, and completion of Meadowbrook Lane to the south property boundary. Also included as part of this project will be a stormwater detention facility, between Alfalfa Crescent and Meadowbrook Lane, to control drainage in this developing area. Final site plan application is expected next month, to be followed by posting of sureties, scheduling a pre-construction meeting and issuing a notice to proceed. Earthwork on the site is anticipated to begin this summer.

## 2024 Town Projects underway....

Brickyard Road Water Tower Replacement and water transmission line installation (approximately 13 million dollars) - East side of Brickyard Road, north of Yerkes Road extending to the Canandaigua/Farmington Town Line Road. Construction to begin this spring and be substantially completed in early 2026.

Phase 1 Sidewalk/Trail Connection/Bike Lane Capital Project. (approximately 2.1 million dollars). Linking missing sections of sidewalks within areas along State Route 96, County Road 41, Mertensia Road and Beaver Creek Road. Also includes a pedestrian/bicycle bridge crossing of Beaver Creek, and additional hiking/walking trail connection to the Auburn Trail. Construction to begin this spring and be Substantially completed by October 31, 2024.

Parks & Recreation Master Plan Update - Updating the 2018-2022 Parks & Recreation Master Plan. Involves Residents Survey, planning committee meetings and public hearings on future park and recreation program priorities. (See Survey information below)

# **Building Department**

Hello Farmington Residents! It's the most wonderful time of the year....winter! It's been an interesting winter so far but just remember spring is right around the corner!

We would like to welcome Cadin Lloyd to our department! He joined our team back in September and he brings vast experience and knowledge to the Building Department. You may have already seen him driving in your neighborhoods getting the lay of the land. If you see him give him a wave and welcome him to our amazing Town.

Our Fire Marshal, Augie Gordner, would like to remind the residents to clean and have your chimneys inspected by a professional and only burn approved fuel sources. With colder temperatures and snow, you want to make sure your furnace intake and exhaust are kept clear from snow or debris, this also includes fire hydrants in the vicinity of your home. Those need to have a three-foot clear space around them. Lastly, always be sure to test and inspect all your smoke detectors and carbon monoxide (CO) detectors on a monthly basis. If you do not have these safety devices, please contact the Farmington Fire Department as they can assist in providing free or low-cost smoke and carbon monoxide alarms. They are a cost-effective way to ensure your family's safety and should be added to all occupied structures. Inspect the detectors for damage, press the test buttons to test the alarm, and replace batteries if needed. It is good practice to replace batteries annually regardless of test results.

A reminder that parking over sidewalks is against the Town Code. Please do not park your vehicles on the sidewalk or in your driveway covering a portion of the sidewalk. Doing so can cause safety concerns for pedestrians and make sidewalk snow clearing operations increasingly difficult.

As the winter arrives, and your projects may be nearing completion, it is important to arrange for final inspections to close out any open building permits on your property to receive a Certificate of Compliance/Occupancy.

**CERTIFICATE OF OCCUPANCY/COMPLIANCE**: Your project is not complete until a final inspection has been performed by our office and a Certificate of Occupancy or Certificate of Compliance has been issued. It is the homeowner's legal responsibility to ensure a building permit has been issued, inspections have been performed, and Certificate of Occupancy/ Compliance are issued prior to the building permits expiration. The Ontario-Wayne Stormwater Coalition (OWSC) would like to give you some tips for reducing pollutions this winter:

- 1. Shovel as soon as possible after a snowstorm. As a result, less ice will form, and you won't need to use as much salt or de-ice.
- Use safe and effective alternatives to salt. Remember that salt is not effective below 15 degrees Fahrenheit. Sand or kitty litter will give you traction when it's too cold for salt.
- 3. Plant native species, that are salt tolerant, near paved areas. Not only will these species be able to survive despite the road salt, but they will also act as a protective buffer for local waterways.
- 4. Make sure the storm drains closest to your property are clear of snow and other debris. Do not shovel snow into storm drains since they empty directly into local creeks.



# From the Assessor's Office Donna LaPlant

Hello Farmington and Happy New Year!

In this newsletter, I would like to discuss fair assessments and the benefits of frequent reassessments. The fairness, or equity, of the real property tax depends on whether similar properties are treated alike. By keeping assessments up to date each year, assessors can go a long way towards ensuring that taxpayers do not pay more or less than their fair share of taxes. As Assessor, that is my goal and the reason why Farmington typically does townwide revaluations every other year.

There are several benefits to frequent reassessments. In doing so the town receives state aid. However, there are other benefits to be aware of such as

 Assessment Equity for all Taxpayers - The longer it has been since a municipality has updated assessments, the more likely that some taxpayers are paying more than their fair share of taxes.

For example, if a specific neighborhood within the town is not seeing a drastic increase in market values, but another neighborhood within the town is, the neighborhood not seeing the drastic increase would be paying more than their fair share in taxes until a revaluation is done. If assessments are adjusted after years and years of neglect, the "sticker shock" would be much worse than if done after just a couple of years.

- Local control over the equalization rate By maintaining assessments at market value each year, municipalities can consistently receive an equalization rate of 100. This eliminates shifts in both school and county tax apportionment due to fluctuating equalization rates.
- Fewer court challenges to assessments By keeping assessments up to date, municipalities are likely to have fewer tax certiorari cases which saves the town significant money.

With that being said, I am anticipating completing another townwide revaluation project in 2025. Data mailers will be

sent out within the next few months that show the inventory we have on file for your property. Having accurate inventory on our records ensures a fair assessment will be placed on your property.

## Highway Department Tim Ford, Highway

As Spring arrives, Highway Crews will be out to repair snow plow damage caused by our plow trucks and removing plow marker stakes. Also as they do every year, they will be picking up litter & trash from the sides of Town Roads. The Highway Department is presently preparing for a busy summer with several road projects. The road projects for this year are as follows: 8 miles of Chip Seal on Fox Road, Ellsworth Road, Yellow Mills Road, Rushmore Road and Mt. Payne Road. Roads that will be Milled & Filled are Clovermeadow Lane, Belmont Drive, Bridle Path, Doe Haven Drive, Canandaigua-Farmington Town Line Road (between State Route 332 and County Road #8) and Sand Hill Road (State Route 96 - Latting Road). A cold-in-place recycle with an  $1 \frac{1}{2}$  overlav is to be done on Shortsville Road from (County Road 28 to the Shortsville Line). Our Capital Project is in the planning stage to rebuild Cranberry Drive in the Farmbrook Subdivision. We will publish time frames on the town website for each of the scheduled projects as closely as we can with the understanding that some scheduling depends on specialized contractors and equipment, as well as weather. As always, we will try to minimize any inconveniences in your commute and apologize for any that we may cause.

With spring and summer approaching, it brings out walkers as well as children playing in our neighborhoods. Please be mindful of your speeds while driving on our roads.

### PARKS

The following park projects were completed in the Farmington Parks in 2023:

**Mertensia Park** - 5-12 year playground (Mountain Pass), 2 Tennis courts were resurfaced and striped with pickle ball striping, and basketball court resurfaced.

**Farmbrook Park** - 5-12 year playground (Mountain Pass), new doors on bathrooms, new roof on bathrooms and Pavilion.

During the winter months, the Park's Department has been busy keeping the residential sidewalks and town parking lots cleared of snow. Along with this we have been doing our normal maintenance and repairs to the mowing equipment, picnic tables and park benches in preparation for the upcoming spring.

In the Spring when it looks like the snow is done, crews will be out to repair any lawn damage caused by our snowblowers as well as picking up the guide stakes along the sidewalks.

**Pumpkin Hook Park** will be getting a new 5–12-year-old playground to replace the old one. **Town Park** Pavilion is scheduled to be built this Spring.

In the **Farmington Grove Park** the old ice-skating rink and basketball court will be turned into additional parking. The lower parking lot will be expanded and the baseball field will be improved to allow for Little League baseball games to be played there.

On December 4<sup>th</sup>, the South Farmington Friends Cemetery Association was listed on the New York State Registry of Historic Places. National approval is pending. ## Water & Sewer Department Robin MacDonald, Acting Superintendent

2024 Projects include replacing the Brickyard water tower and a new 16" transmission line mentioned in Ron Brands notes earlier in this newsletter. As part of the Cranberry Drive total rebuild mentioned by Tim Ford, we will also be replacing some of the water & sewer lines. In the design stage and hopefully bid in 2024 is to replace another section of Mertensia Road watermain north of the apartment complex and going past Elizabeth way. The next project under design is to replace the waterline on Collet Road under NYS Route 332.

We would like to remind Canandaigua-Farmington Water/Sewer customers that you can now sign up for you bills to be sent to you by email. This eliminates your bill being lost in the mail. We will provide more information with your next bill or just call our office for more information.

This spring & summer we are required by the EPA to locate water services in your front lawn for all homes built before 1986. This is a gigantic task as we have a deadline of October 1<sup>st</sup>. Please be patient during this process, it is our intention to make as little a mess in your lawn as possible.
