# PUBLIC HEARINGS- Tax Cap Override

Supervisor Ingalsbe opened the public hearing at 7:00 p.m. The Town Clerk read the legal notice. Supervisor Ingalsbe stated that at the last meeting the Town Board approved the setting of a public hearing for tonight to override the tax cap which was long before the Governor announced his budget. Supervisor Ingalsbe started out with a little history regarding the tax cap override. He stated that June 24, 2011, Chapter 97 of the Laws of 2011was signed into law by Governor Cuomo, the tax limitation applies to all towns and villages, counties and schools (editorial in the Nov/Dec 2011 Associations of Towns magazine) and it also implies to all improvement districts as apparent in the town tax levy. He added that part of that history, because of the new law, the very first resolution the Town Board did was back in October 2011 for fiscal year 2012. He added that every year after that, the town has done the same resolution in January or February for every preceding year. Supervisor Ingalsbe stated that this local law will be for 2021 budget year. He added that the formula is very complicated and there is a whole page of criteria that the Account Clerk has to fill in in order to get to a bottom line number. He added that over the last six years the budgets have been three years over the tax cap and three years under the tax cap. He added that the town tax rate in the General and Highway Funds for 2013 was \$1.10 per thousand, 2014 went up a penny to \$1.11 per thousand, 2015 through the current year 2020 the tax rate had stayed the same at \$1.10 per thousand. Supervisor Ingalsbe stated that the resolution that they have done in the past and right now to override the tax cap really doesn't a whole lot to do with the tax rate. He added that the highest tax rate he could find was \$1.45 per thousand, in 2002 it was \$1.40, and now we are at a \$1.10. He stated that the water tax rate in 2002 was \$1.03 per thousand and now they are at \$.75 per thousand; fire protection is 2002 was 73 ½ cents per thousand, last year was \$.64 and for 2020 it is down to \$.60 per thousand. Supervisor Ingalsbe stated that the budget tracks 38 separate funds. The budget process starts in June or July and has to be adopted by November 20th of every year. The town has never rescinded the tax cap resolution in all these years because they never know when the State Comptrollers office will want to come in and do an audit. He added that every town and even the county does this resolution this time of year.

Councilman Bowerman stated that what he has heard is that many think this is a law to raise property taxes and that is not the case, it is merely a resolution the Town Board has done for many years just in case they do go over the tax cap and in three of those past six years when they have gone over the tax cap, the tax rate changed maybe by a penny or two.

Supervisor Ingalsbe asked if anyone want to speak for or against this proposed local law. Mr. Dave Younis, resident, commented on the Governor's news that the 2021 budget will exclude VLT monies and in this particular incidence he is a little more sensitive to a resolution than in previous years. He is curious to see if any analysis has been done at this point regarding the loss of this revenue. Supervisor Ingalsbe responded that it is too new and that this budget came out before that news and the board hasn't study it yet but he does have a meeting Friday with Finger Lakes Gaming and Racing and the County Administrator, Victor Town Supervisor Marren who is the Chairman of the Board of Supervisors for Ontario County and Senator Pam Helming to discuss fighting the VLT and putting it back in the Governor's budget. He added that the Governor has until February 20<sup>th</sup> to put anything back in the budget but if it's not put back in by then it will be up to the legislator to put it back in. He said what they have going for them is this affects 8 counties and 15 municipalities and everyone of them will be reaching out to their state legislators or assembly asking for this money to be put back in.

Supervisor Ingalsbe stated that some of the communities put that money as part of their operating expense in their budget, the town does not do that, the town sets that money aside for special projects then if the town needs a little bit to offset the tax rate they can use it. He added that they town still has part of 2017, all of 2018 and 2019 money that they haven't spent yet. He added that they haven't spent all of 2016 but it is in capital projects and half of 2017 is in capital projects. He explained that capital projects are highway funds to rebuild Townline Road which the cost is shared with Canandaigua, Beaver Creek Park, Mertensia Lodge, Highway Campus, Town Court Facility, and the Town Hall Expansion and Renovation project. No tax increase due to using VLT monies. He added that with the existing money the town has they are not going to spend it foolishly, they are going to put it towards capital projects, if they money dries up then they do less capital projects, and if they have to raise the tax down the road to put more money into the highway and parks, safety things, they are diligent on the budget, staff is all involved in the process.

Supervisor Ingalsbe closed the public hearing at 7:17 p.m.

Supervisor Ingalsbe stated that there is a short survey online for the Comprehensive Plan update.
