BRICKYARD ROAD TANK AND TRANSMISSION MAIN**

ADVERTISEMENT FOR BIDS

In accordance with Section 103 of Article 5-A of the General Municipal Law, sealed Bids for the construction of the Brickyard Road Tank and Transmission Main will be received by Canandaigua-Farmington Water District, at the office of the Town of Farmington, 1000 County Road 8, Farmington, New York 14425, until 2:00 PM local time on December 2, 2021, at which time the Bids received will be publicly opened and read.

The Work generally includes the construction of 12,000+/- LF of new 16" and 12" Water Transmission Main, removal of the existing 1.0 MG Water Storage Tank and construction of a new 2.0 MG Water Storage Tank. Work is generally located at the Brickyard Road Tank site, and along Brickyard Road and Purdy Road. Included in the Work are connections to the existing watermains, construction of two (2) new precast concrete vaults, removing an existing water storage tank, construction of a new water storage tank including a mixing system, telemetry, and other miscellaneous improvements and associated site work.

Separate sealed Bids will be received for:

- Contract No. 1 – Contract #1: General;
- Contract No. 2 – Contract #2: Tank;
- Contract No. 3 – Contract #3: Electrical; and
- Contract No. 4 – Contract #4: Mechanical

Bids for Contract No. 1 shall be on a unit price basis as indicated in the Bid Form. Bids for Contract No. 2, Contract No. 3, and Contract No. 4 shall be on a lump sum bases as indicated in the Bid Form.

3. For a non-refundable fee, printed copies of the Bidding Documents may be obtained from the Avalon Planroom. If the documents are to be shipped, the Bidder must furnish Avalon with the Bidder's active UPS or Federal Express account number or pay Avalon for all shipping and handling costs.

The Bidding Documents must be obtained through the Avalon Planroom in order to be considered a Plan Holder of record. Bidding Documents obtained from any other source are for examination only, are not considered complete and are not valid for bidding purposes.

Bidding Documents also may be examined at the offices of MRB Group, the Town of Farmington Town Hall, 1000 County Road 8, Farmington, New York 14425, on Mondays through Fridays between the hours of 9:00 AM and 3:30 PM; or online through internet based construction information subscription services.

The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Canandaigua-Farmington Water District, nor Engineer, nor Avalon will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

The Canandaigua-Farmington Water District, Ontario County, New York, reserves the right to reject any or all bids, or to waive any informalities, or to make an award to other than the low bidder. It further reserves the right to limit the amount of the award.

Attention of the bidders is particularly directed to the requirements of the conditions of employment to be observed and minimum Wage Rates to be paid under the Contract.

The Canandaigua-Farmington Water District does not discriminate on the basis of handicapped status in admission or access to, or treatment or employment in, its programs and activities.

A Pre-Bid Conference will be held on November 18, 2021 at 10:00 AM local time at 1000 County Road 8, Farmington New York. Representatives of Owner and Engineer will be present to discuss the Project. Attendance at the pre-bid conference is highly encouraged but is not mandatory.

Bid security shall be furnished in accordance with the Instructions to Bidders.
