Town of Farmington (Owner) is requesting Bids for the construction of the following Project:

Cline Road & Brownsville Road Highway Improvements

In accordance with Section 103 of Article 5-A of the General Municipal Law, sealed Bids for the construction of the Project will be received at the office of the Town of Farmington, located at 1000 County Road 8, Farmington, New York 14425, until March 21, 2023, at 10:00AM local time. At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

Project involves approximately 1,100 LF of road reconstruction along Cline Road and Brownsville Road including: removal of the existing storm sewer and structures, removal of the existing pavement to design subgrade, installation of new base and asphalt pavement, installation of storm drainage improvements, road side ditch drainage, topsoil and seeding.

Sealed Bids are requested for the following Contract: Contract #1: General

Project has an expected duration of 180 days.
