Town of Farmington (Owner) is requesting Bids for the construction of the following Project:

Grove Park Site Improvements

In accordance with Section 103 of Article 5-A of the General Municipal Law, sealed Bids for the construction of the Project will be received at the office of the Town of Farmington, located at 1000 County Road 8, Farmington, New York 14425, until March 19, 2024, at 10:00 AM local time. At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

Construction of new parking facilities, driveways, sidewalks and lighting, as well as the restoration of the existing parking lot and driveway, at Grove Park in the Town of Farmington. Also included is the removal of an 85' x 205' asphalt former skating rink. A 39 space parking lot will be constructed at the location of the skating rink and it will be connected to the existing parking lot by a new drive aisle that also has 15 proposed parking spaces. The existing parking lot and driveway will be milled and resurfaced. The Work also includes the installation of sidewalks, drainage piping, drainage structures, signage, lighting and striping.

Sealed Bids are requested for the following Contract: Contract #1: General
