PUBLIC HEARINGS: Adoption of the Town of Farmington Sidewalk Trail Master Plan Map as an amendment to the 2021 Comprehensive Plan

Supervisor Ingalsbe stated that due to an administrative error the legal notice was not published in the newspaper therefore they were rescheduling the public hearing for September 22, 2021, at 6:30 p.m. No one appeared in person or online for this public hearing.

APPROVAL OF MINUTES:

A motion was made by **Councilman Bowerman** and seconded by **Councilman Holtz**, that the minutes of the September 14, 2021, Town Board Meeting, and given to members for review, be approved. All Voting "Aye" (Holtz, Casale, Herendeen, Bowerman, and Ingalsbe). Motion Carried.

PRIVILEDGE OF THE FLOOR: Mike Putnam, John Moore, and Terry Taber – residents on Elmwood Drive – update on drainage issue

Mr. Giroux, Highway and Parks Superintendent, stated that he went out and looked at the issue northbound and all the vegetation was cut and removed from the ditch to help relieve the water when it is in there so it can exit sooner but as far as the water that is coming into there, he stated that is not going to change as the way the drainage is laid out down through there. Supervisor Ingalsbe stated that he will also have the town engineer look at it. Mr. Giroux added that he did not disturb the base of the ditch. Mr. Putnam stated that the vegetation is still there at the corner where the storm drain comes on through from Elmwood Circle. Mr. Giroux stated that from that ditch to the north along Laviano's property. Mr. Giroux added that they come to the property line behind the homes along the hedgerow. Mr. Putnam replied that it did not look like this afternoon. Mr. Delproire, Code Enforcement Officer, stated that he also went and looked at what the Highway crew did out there and stated that the ditch has been cleaned out right up to the back of the property lines and it does not look like there is any restriction of flow there. He added it was a good improvement by the Highway Department.

Mr. Moore stated that he certainly isn't an engineer but looking at it they have this huge retention pond and the way it seems to be designed, water inflow doesn't seem to go into the pond, there is a huge deep basin that is only being filled up very insignificantly thereby any water is coming in is flowing into their yards during very vast storms. He is curious as to why things are not designed so that in could run into the pond via the retention pond holding the water until the storm passes then you would have gradual outflow of that water. He asked if any other resources could be done. He added that vegetation will just grow back just like the mowing around the pond which is mowed every 6-8 weeks. He thought maybe piping could be done into the pond somewhere where is it not a nuisance to the property owners. Supervisor Ingalsbe stated that the ponds that are west of their property are designed to take the water flow from Auburn Meadows and hold it and release it at a slower rate. Mr. Davis, town engineer, stated that the ponds that are there were not built to alleviate the water way that is behind their homes, but they were required to be put in by the developer to retain the water coming from the west to make sure there is no negative impacts to the waterway as it was existing before that development occurred. He added that is how the stormwater regulations are set-up by the State and they make sure that whenever there is any development that there is no negative impact or any increase in water flow off those properties, when they do get developed, using stormwater structures and even stormwater treatment when it becomes necessary. He added that they did look at the ponds and the elevation, it is a shallow pond. He stated that they did look at drainage patterns and there were no major changes that would impact the waterways. He believes what the Highway Superintendent has done so far by addressing the vegetation that may have been trapping some water in there will help. Mr. Giroux added that we have had abnormal rain events which amplifies their situation. He added that the water flows on Townline Road have not been altered and the town has to maintain how they normally flow and not reroute it. Mr. Putnam stated that there was water just sitting in the ditch behind Mr. Taber's home today. Supervisor Ingalsbe stated that they are going to have that. Mr. Giroux asked how much water was sitting there, Mr. Putman replied about six inches. Mr. Giroux stated that he would have to go back and look because he does not know if there is an area through the wood line and with that said he would have to get into his backyard to clean it up but he will take a look and see if there is a small area there where he can address between the catch basin on the corner that dumps out into his back yard to see if there is additional cleaning to be done right there. He stated that water coming in from the south is not something they can change and hopefully they won't keep getting the rain events that they have been getting. Mr. Moore stated that they also get the same affects

with snow and ice when it melts. He spoke on behalf of Mr. Fredricks who could not be at the meeting regarding his concern about the large pine tree in his backyard and the possibility of it falling onto his home. Mr. Giroux replied that he can look at it and see if the tree is in the town right-of-way then he might be able to do something but if it is on private property then there is nothing he can do. Mr. Moore stated that he understands what Mr. Giroux is saying but the water is beyond any control of Mr. Fredricks and it is threatening his property and if there were a recourse financially so that threat can be removed certainly would be looked at favorably. Mr. Giroux stated he will look into it and then talk with the Town Board; he will see where the actual placement of the tree is located and try to assess how much of the stream is affecting the stabilization of the tree. Mr. Moore added that it is too much water for that type of tree and they just turn brown and die. Mr. Giroux replied that the trees have lived there for approximately 40-50 years so he doesn't understand why all of a sudden they're dying. He added that the town cannot regulate how much water will run down into that ditch, all they can do is try to remediate the ditch line so that it flows at its best capacity to the north to relieve water so that it does not build up there.

Mr. Putnam asked why the town can't change the water if it is coming off from town property. Supervisor Ingalsbe replied that the DEC will not allow the town to dig new channels and elevations have a lot to do with it. Mr. Davis stated that this has been an issue with many areas throughout the town and that Farmington is very flat and that is why there is a lot of great farmland here but there is also a lot if drainage issues that go along with it.

Supervisor Ingalsbe suggested they reach out to Ontario County Soil and Conservation and see what they think. He also asked the Mr. Delproire and Mr. Giroux to coordinate with them and see if anything can be done.

PUBLIC CONCERNS: Mr. DeRoo-5795 Canandaigua-Farmington Townline Road- Sewer

Mr. DeRoo inquired about the possibility of having town sewer. Resident is in the Town of Canandaigua. Supervisor Ingalsbe stated that he did have a conversation with the Town of Canandaigua Manager, Doug Finch, about three months ago and he thought the Highway Superintendents from Farmington and Canandaigua to talk about this. He added that there is not an easy plan on how to flow from Mr. DeRoo's current septic system to a sewer line. He added that it is either the sewer has to go back southwest to Stablegate or some expensive hookup under Townline Road. Water and Sewer Superintendent, Mr. MacDonald, stated that the elevation where those houses are is low enough, so it is an uphill battle to have sewer there. He added across the road is private sewer. Mr. Davis stated he thought the only way Mr. DeRoo would be able to do it is to put in grinder pumps or some type of pressurized system. Mr. Davis stated that Mr. DeRoo needs to contact the Town of Canandaigua.
