Thank you again for allowing us to host the open house at the Town Hall this Tuesday. The event was very well received, and it was great to be able to answer questions and talk directly with residents in a more casual setting.

Attached is the sign-in sheet we had at the meeting room door - we made sure to have everyone who entered the meeting room sign the sheet. All together about 18 people stopped by, and 12 attended to talk with us.

DRS staff had conversations with each person in the meeting room, and we answered many questions about the project, and Community Solar. Nearly everyone encouraged the project, and supported it. Almost all who attended signed the petition in support, which is also attached. We are still gathering more signatures, and will formally submit the petition to the Planning Board next week.
