ACTIONS: DELAWARE RIVER SOLAR, LLC, 7 M W SOLAR PHOTOVOLTAIC PROJECT ACTION – AMENDED PRELIMINARY SUBDIVISION PLAT, AMENDED PRELIMINARY SITE PLAN, A SPECIAL USE PERMIT AND A DRAFT STORM WATER POLLUTION PREVENTION PLAN (SWPPP) FOR SAID APPLICATIONS.

LOCATION: SOUTHWEST OF THE INTERSECTION OF FOX ROAD AND YELLOW MILLS ROAD, IN THE TOWN OF FARMINGTON, ONTARIO COUNTY, NEW YORK

NOTE: THE TOWN OF FARMINGTON PLANNING BOARD IS AGAIN INITIATING THIS COORDINATED REVIEW OF THE ABOVE REFERENCED REVISED TYPE I ACTION. THE PLANNING BOARD AS THE DESIGNATED LEAD AGENCY HAS PREVIOUSLY MADE A DETERMINATION OF NON-SIGNIFICANCE UPON THE ORIGINAL APPLICATIONS. SINCE THAT DETERMINATION, THE APPLICANT HAS REVISED THE PRELIMINARY SUBDIVISION PLAT AND PRELIMINARY SITE PLAN DRAWINGS. IN ADDITION, THE APPLICANT IS NOW PROVIDING A STORM WATER POLLUTION PREVENTION PLAN (SWPPP) DOCUMENT. THE TOWN PLANNING BOARD INTENDS TO COMPLETE ITS REVIEW OF THE ANTICIPATED IMPACTS LIKELY TO RESULT FROM THE REVISED DRAWINGS AT THEIR MEETING ON WEDNESDAY, NOVEMBER 20, 2019 UNLESS WE ARE NOTIFIED OF ANY AGENCY’S CONCERNS, OR IF AN INVOLVED AGENCY NEEDS ADDITIONAL TIME TO COMPLETE ITS’ REVIEW OF THE AMENDED ACTIONS.


