This is important to all of Kansas City and this monument for many years to come.

Emphasis this year will be on growing our membership. This organization began in 1932 by a group of dedicated Kansas Citians who wanted to "preserve history and the heritage of the Greater Kansas City metropolitan area (two states and ten counties) through advocacy, education and restoration", to partially quote from the NSDKC Mission Statement.
