#### Letter from the President

With our economic environment growing ever more troublesome daily, we as the responsible stewards of our organization, are obliged to focus on the financial management of our resources to ensure the preservation so necessary to our future operations. A more intense awareness will be necessary in our day to day operation's expenses.

Toward that end we have taken steps to aid our operating procedures; the President's Advisory Committee is but one example. The creation and staffing of our Communications Committee is but another. Working Committees aid out total effort but when their work involves organizational policy, it must be viewed as in the nature of recommendations, not organizational policy. We must not short-circuit the Board's authority nor move too hastily or we present new problems for operations, internally and externally; operating expenses and staff, paid and unpaid, can be carefully managed without unduly hampering those operations which have served us well over the years.

Recently, our Vice President, Dan Sturdevant, prepared a letter I approved, listing steps 1 through 8 and their timing, to tighten operations toward the end of making them more efficient and timely. Strict observance should improve our efforts to serve the community in the preservation of our ten county Kansas City history. If those time tables are generally acceptable to our Board then their timing could be adjusted to fit each quarter of operations throughout the year's operations.

There is a need for strengthening our operating systems for future guidance of our Administrative Secretary and all working Committees. Toward that end I have forwarded to our Marker's Chairman, Roger Smith, and our President's Advisory Committee for policy adoption consideration, my 4 page authored summary of "Suggested Guidelines for Evaluations of Locations for Marker Placement." Those were drawn from the "National Landmarks Standards."

I can only hope the spirit of these efforts might draw others into stronger support of and for NSDKC.

Thirty-two people joined Ross Marshall on the Trails West bus tour sponsored by the Native Sons and Daughters of Greater Kansas City on Saturday October 11. The all-day bus tour started in downtown Kansas City at 8th and Jefferson, also called Lewis and Clark Point. Mr. Marshall then led the bus on a path to the Town of Kansas site, the Alexander Majors house at 82nd and State Line, Lone Elm Park at 167th and Lone Elm Road, Three Trails Junction west of Gardner Kansas, Mahaffie Stagecoach Stop in Olathe, Kansas, Sapling Grove Park at 83rd and Grant and to Pioneer Park on 56 Highway in Shawnee Kansas before arriving at about 5 p.m. back home.

The Kansas City area's four National Historic Trails in the first half of the 19th century America seemed to come alive through Ross's excellent history-telling and through interpretive panels.
