## Jeannette Nichols Named 2006 Outstanding Kansas Citian

On October 5, the Native Sons of Greater Kansas City will honor one of Kansas City's great philanthropists and community volunteers when it names

Jeannette Nichols Outstanding Kansas Citian for 2006 at a reception held in her honor at the Liberty Memorial, 100 W. 26th Street.

Accomplishment is part of the Nichols' family tradition. J.C. Nichols, Ms. Nichols' father-in-law, created the Country Club Plaza in 1922. Her husband, the late Miller Nichols,

took over his father's business and took the Kansas City landmark to new heights by adding hotels, apartments and artwork to the Plaza landscape.

Jeannette Nichols' own accomplishments are just as renown, especially in the arts. She serves as honorary co-chair of the University of Missouri - Kansas City's \$200 million capital campaign and is spearheading the expansion of the Miller Nichols library on the UMKC campus.

She and her late husband, Miller, received the Philanthropic Award from

the Jackson County Historical Society in 2001.

Two years later, Ms. Nichols received the William F. Yates Medallion

of Distinguished Service from William Jewell College.

She serves on the Campaign Steering Committees of both the Kansas City Public Library and the Metropolitan Kansas City Performing Arts Center.

She has even served at the national level on the President's Advisory Committee

on the Arts at the John F. Kennedy Center for the Performing Arts in Washington, D.C.

The Native Sons of Greater Kansas City are pleased to name Jeannette Nichols Outstanding Kansas Citian for 2006.

The 2006 event will be a special homecoming for many Native Sons who worked hard to see the Liberty Memorial restored to its former glory. Now members have a chance to honor a living legend at one of Kansas City's greatest landmarks. **JN**

### NATIVE SONS AWARD PRIZES TO STUDENTS

Since 1992, the Native Sons of Greater Kansas City has supported regional History Day students by annually awarding prizes of \$100 to the best entries in the Missouri and Kansas State History Day contests on topics relating to the history of the Kansas City area.

This year one of the Native Sons Prize winners from Kansas earned special recognition at Nationals by coming in First in the group documentary category for the junior division. Sjobor Hammer and Anna Hamilton, both 14 and who were eighth-graders at Topeka Collegiate this past school year, researched, wrote, and produced a 10-minute video, Lighting the Dark Places: Esther Brown and the Webb v. School District No. 90 Case. The documentary explored the Merriam, Kansas, school segregation case that preceded Brown v. Board of Education.

Receiving the Native Sons Prize for Missouri was Michael McCormick of Risco, Missouri, for his Senior Individual Performance, *Unredeemed Rebel: The Legend of Jesse James*. Michael demonstrated his research by writing a script and assuming the character of governor of Missouri, Thomas T. Crittenden agonizing over what to do about Jesse James.

All the students who enter the National History Day contests, learn valuable skills for understanding, and an appreciation of history.
