### **REFERENCE**

The NMAS Constitution defines a Junior as a member who is under the age of eighteen years.

### **PURPOSE**

This MOP provides for club access to Wings rated Junior members, while aiming to ensure their safety by requiring a Parent or Guardian to also be present.

### **POLICY**

Upon written request to the club Secretary, the Parent or Guardian of a Junior member who has achieved Bronze/Silver status can be issued with a key, under the following conditions:

1. The committee reviews and approves the request.
2. The Parent or Guardian must be with the Junior at all times whilst at the NMAS field.
3. The parent or Guardian agrees to be custodian of the issued key and is responsible for its proper use.
4. The Parent or Guardian is to be inducted with regard to security and safety requirements of the Club.
5. The key can be taken back if the above conditions are not followed.
6. The Parent or Guardian is to fill out and sign the attendance book.

### **RESPONSIBILITY**

It is the responsibility of the committee and all members to ensure that these procedures are adhered to.
