**LISA Comment:** Our investigations into the DHS Expo at Lonsdale Street on July 9. 2012, revealed a 'cone-of-silence' by DHS. Victoria. Clearly, we should not have received the above information!

After numerous telephone calls, it was revealed that those representing people with a disability and their families were not welcome at this DHS Expo. Yet another very clear example of the "*Them & Us*" culture which exists in abundance in the present captive market service provision throughout the State of Victoria.

The "Them & Us" culture, especially prevalent throughout DHS direct services, is further enhanced by such restrictive practices as keeping the actions of service providers isolated from consumers and their families. This restrictive practice is especially devastating where consumers are trapped in a captive market.

We suspect it will require FOI action to determine the practical implication of, "CQL Named Independent Review Body in Victoria." And the contract details underpinning, "CQL proud to be an endorsed independent review body by the Victoria Department of Human Services". True and transparent independent accreditation is that which helps to reduce questionable activities behind closed doors. And helps to give families some peace of mind regarding the care of their vulnerable adult member.

Within the present captive market service provision, and the restrictive practice outlined above, the centre of service provision remains the service provider, rather than the person with a disability and their family.
