- 4. Now produced and shown to me and marked "RS-1" is an indexed paginated bundle of the documents referred to in this Affidavit.
- Prior to making my investment in the LM First Mortgage Income Fund, I was provided with a
 Product Disclosure Statement and Application Form issued 10 April 2008, a copy of which is at
 pages 1 to 63 of Exhibit RS-1.
- 6. I invested in the Fund to obtain a regular monthly income. That has not transpired as interest payments ceased in about mid-2009. Also, I recall that in about mid-2009, I was notified by LM Investment Management Limited that redemption requests were suspended, so I could not obtain a return of my investment.
- 7. At page 64 to 71 of Exhibit RS-1 is a copy of my Application Form pursuant to which I invested US\$260,000 for a 6 month term.
- 8. On or about 30 September 2011, I received a Consolidated Distribution Statement for the year ended 30 June 2011, which noted that the unit price of units in the FMIF was US\$0.80 and that my account value had been reduced to US\$215,541.87. A copy of that appears at page 72 of Exhibit RS-1. I have since been advised by LM Investment Management Limited that the unit price has been written down to 55 units per unit as at 31 December 2012.
- 9. In late December 2012, I received a letter from by LM Investment Management Limited dated 20 December 2012 advising of:
 - (a) an orderly sale of all remaining assets of FMIF;
 - (b) the unit price as at 30 June 2012 was 59 cents; and
 - (c) redemption requests had been suspended since mid-2009.
