### **Terms and Conditions – Association of Australasian Diesel Specialists Inc. (AADS)**

These terms comprise a binding written agreement between The Association of Australasian Diesel Specialists Inc. (Inc – 0020431) of Level 3, 33-35 Atchison Street, St Leonards NSW 2065 (“AADS”) and you (“Participant”)

#### **Agreement**

By agreeing to these Terms and Conditions you acknowledge that you are registering for membership of AADS or to attend an event hosted by AADS and all fees associated with your participation are payable in full as per AADS’s payment terms. You may register on behalf of others, however you are deemed to be liable for all associated fees for all memberships and event participants you register.

#### **Registration Confirmation**

On completion of your registration, a confirmation email will be sent to your nominated email address. Please check your registration carefully. Should an error have been made, please contact AADS within 24 hours via email or phone +61 2 9431 8685 to withdraw or amend your registration. Should you not contact AADS within 24 hours, a cancellation fee will apply

#### **Registration Payment Terms**

Payment of your registration fee and any selected additional items are due on completion of your registration. A tax invoice will be emailed to you with confirmation of your registration. A copy of your tax invoice is available via your dashboard at any time. All fees must be paid prior to commencement of an event to ensure admission, unless by prior arrangement

#### **Registration Cancellation Policy**

Should your circumstances change and you are unable to attend the event you are registered for, you must contact AADS by no later than 30 days prior to the commencement of the event. A cancellation fee of \$100.00 will apply to cover costs incurred in relation to your registration. Should you cancel less than 30 days prior to the commencement of the event, no refund will be payable

#### **Credit Card Payments**

AADS accepts credit card payments by Visa, Mastercard and American Express. Credit card details entered via your dashboard will be processed directly by AADS’s credit card merchant. Your credit card details will not be stored by AADS. International Credit Cards, due to the increase in credit card fraud, international credit card payments will not be processed automatically using AADS’s credit card merchant. Your payment will be processed by AADS’s credit card merchant once AADS has reviewed your registration. You may be required to provide a copy of your current passport and a copy of the front and back of your credit card prior to your payment being processed. We apologise in advance for any inconvenience this may cause.

#### **Refund Policy**

Refunds are not payable if you simply change your mind. However, if your circumstances change please contact AADS immediately via email or phone +61 2 9431 8685 to amend your registration or associated requirements.

AADS will refund any fees paid to AADS as a result of amending your registration and/or associated requirements, after taking into consideration the relevant cancellation policy, within 7 business days of receiving a refund request. Should an event be cancelled or postponed due to unforeseen circumstances, AADS will endeavour to process a full refund within 90 days of such circumstances being known.

Refunds will only be processed to the credit card or bank account of the individual, organization or institution from which the payment was received. Should payment have been via cheque you will be contacted to confirm your current mailing address and a cheque will be mailed to you.

### Provisions

1. When we communicate with you we will generally do so by email or by phone. You hereby agree that email and phone communications are contractually binding in the same manner as duly signed and dated documentation sent by post.
2. Nothing in this agreement or on our website, [www.aads.com.au](http://www.aads.com.au) or any website owned, operated, licensed or controlled by AADS shall confer on any third party any benefit or obligation.
3. If any of these terms is at any time held by any jurisdiction to be void, invalid or unenforceable, then it shall be treated as changed or reduced, only to the extent minimally necessary to bring it within the laws of that jurisdiction and to prevent it from being void and it shall be binding in that changed or reduced form. Subject to that, each provision shall be interpreted as severable and shall not in any way affect any other of these terms.
4. No waiver by us, in exercising any right, power or provision in this agreement shall operate as a waiver of any other right or of that same right at a future time; nor shall any delay in exercise of any power or right to be interpreted as a waiver.
5. In the event of a dispute arising out of or in connection with these terms or any contract between you and us, then you agree to attempt to settle the dispute by engaging in good faith with us in a process of mediation before commencing arbitration or litigation.
6. We are not liable for any breach of our obligations resulting from clause beyond our reasonable control.
7. This agreement shall be governed by and construed in accordance with the law of Australia, and all international governance is expressly concluded.
