1. ROLL CALL:

2. MINUTES & BILLS:

- A. On a motion by Director Gatto, seconded by Director Saadati, by a vote of 2-0-2, the Minutes of Wednesday, October 17, 2018 were approved. President Bosworth and Director Kwok abstained.
