In consideration of the Texas Medical Center Orchestra d/b/a Gran Fondo Texas ("Gran Fondo") allowing me to participate as a <u>Volunteer or Participant</u> in the Gran Fondo Texas charity bicycle ride occurring on **April 14, 2024** ("EVENT DATE"), I, the Volunteer or Participant, hereby acknowledge and agree to the following.

I acknowledge that this event could be inherently dangerous activity and I fully realize the dangers of volunteering in such activities; and the possibility of serious physical and/or mental trauma or injury or death and FULLY ASSUME THE RISKS, KNOWN AND UNKNOWN, ASSOCIATED WITH SUCH PARTICIPATION including, for example only and without limitation, the dangers of collision with pedestrians, vehicles, participants, and fixed or moving objects; the dangers arising from surface hazards, equipment failure, inadequate safety equipment, my own and other parties' negligence, and weather conditions. Any waiver or modification of any provision contained herein shall not be construed as a waiver or modification of any other provision herein or as consent to any subsequent waiver or modification.
