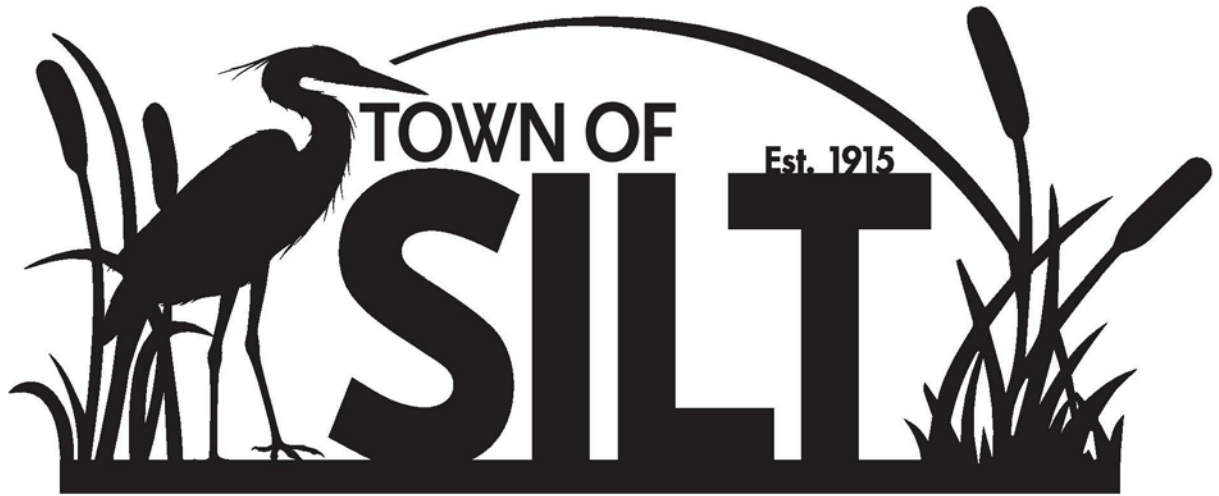

***General Information:***

***Terms:***

At the **April 5, 2022** Regular Municipal Election, five total positions will be on the ballot. A newly elected Mayor and two of the newly elected Trustees will serve four-year terms while two Trustees with the least number of votes will serve two-year terms.

***Meetings:***

Regular Board of Trustee meetings are held on the 2<sup>nd</sup> and 4<sup>th</sup> Mondays of each month. Special meetings are held on an as needed basis. The newly elected Trustees will receive \$400 per month flat rate, regardless of the number of meetings held in a month. *(These amounts are subject to change)*

***Election Code:***

The Town of Silt is a Home Rule Town, and will be conducting the Regular Municipal Election on **April 5, 2022** according to Title 31, Article 10, Colorado Revised Statutes, the Municipal Election Code of 1965, C.R.S. §1-7.5-101 *et seq.*, and the Home Rule Charter. This election will be conducted as a mail ballot election, with ballots mailed to all active registered voters of the Town of Silt.

***Qualifications for Office:***

- \* Registered elector;
- \* At least eighteen years of age; and
- \* Resident of Silt for at least twelve consecutive months immediately preceding the date of election

***Nomination Petitions:***

Candidates are nominated and elected by registered voters who reside within the Town limits. Candidates may begin to circulate nominating petitions on January 4, 2022, and they must be filed with the Town Clerk's office prior to the close of business on January 24, 2022.

A Nomination Petition Form is included with this packet. The petition must be signed by at least twenty-five (25) registered electors who reside within the Town limits. Please plan on obtaining more than the 25 signatures should some of them be rejected. The Candidate must sign the Affidavit of Circulator and the Candidates Affidavit of Acceptance. If the circulator of the petition is someone other than the Candidate, they must sign the Affidavit of Circulator. Both documents must be notarized.

Each office of the governing body that is to be filled by the electorate shall be considered a separate office for the purpose of nomination. The State Statutes require, in addition to a signature, the signor's printed name. Each signature must be legible and every address is to be the street address, **NOT a post office box**. The circulator of the Nomination Petition Form **must witness all signatures**.

**DO NOT remove staples from petitions. If you require additional petitions, please obtain them from the Town Clerk's office.**

***Ballot:***

Candidates' names are placed on the ballot by lot. Names of all candidates who have submitted complete petitions will be placed in a basket and will be drawn one at a time to determine the order on the ballot. Names appearing on the ballot may include a nickname, but shall not contain any title or degree designating the business or profession of the candidate.

***Absentee Ballots:***

Any registered elector of the Town of Silt may vote by absentee ballot. Absentee ballots will be available in the event that you will not be at your primary residence to receive your ballot between the dates of January 5 and April 1, 2022. All applications for an absentee ballot must be made orally or in writing. Applications for an absentee ballot shall be filed with the Town Clerk. In order to be counted, all absentee ballots must be returned to the Town Clerk by 7:00 p.m. on the day of election.

***Election Judges:***

The Town Clerk will select up to five election judges for the regular municipal election. Election judges can begin counting ballots up to fifteen days prior to the election. Judges will work on Election Day until 7:00 p.m. and until all votes have been counted. They are also required to attend an election judges training session prior to the election.

***Voter Registration:***

Residents may register to vote at the Silt Municipal Building, 231 N. 7<sup>th</sup> Street, from 8:00 a.m. until 5:00 p.m., Monday - Friday. Voter registration is also available at all other Town Halls as well as the Garfield County Building in Glenwood Springs and Motor Vehicle offices. In-person voter registration is allowed up through Election Day.

***Mail Ballots:***

The Town of Silt will be having a mail ballot election. Mail ballots will be mailed to all active registered voters no earlier than March 14, 2022. Ballots may be mailed back to Town hall in the envelope provided or hand delivered in the envelope provided to the external voting box located outside of the Silt Municipal Building, located at 231 N. 7<sup>th</sup> Street, Silt, Colorado by 7:00 p.m. Election Day.

***Colorado Fair Campaign Practices Act:***

The reporting requirements of the Fair Campaign Practices Act (FCPA) apply to all municipal candidates. All forms required by the Act must be filed with the Town Clerk. It is the responsibility of the candidate to become familiar with and follow the provisions of the Fair Campaign Practices Act. You can view the Campaign and Political Finance Manual by visiting the Secretary of State website at: [www.sos.state.co.us](http://www.sos.state.co.us). Just click on Campaign Finance on the Home page and the manual can be found under Help & Resources. **Failure to file the proper forms will result in the disqualification of a person as a candidate.** If you have any questions on filing, contact the Town Clerk/Designated Election Official.

***Election Campaign Signs:***

It is entirely up to each candidate to determine what type and how much campaigning he/she would like to do. If you should decide to put up political signs, a copy of the sign code has been provided in this packet showing the guidelines for you to follow.

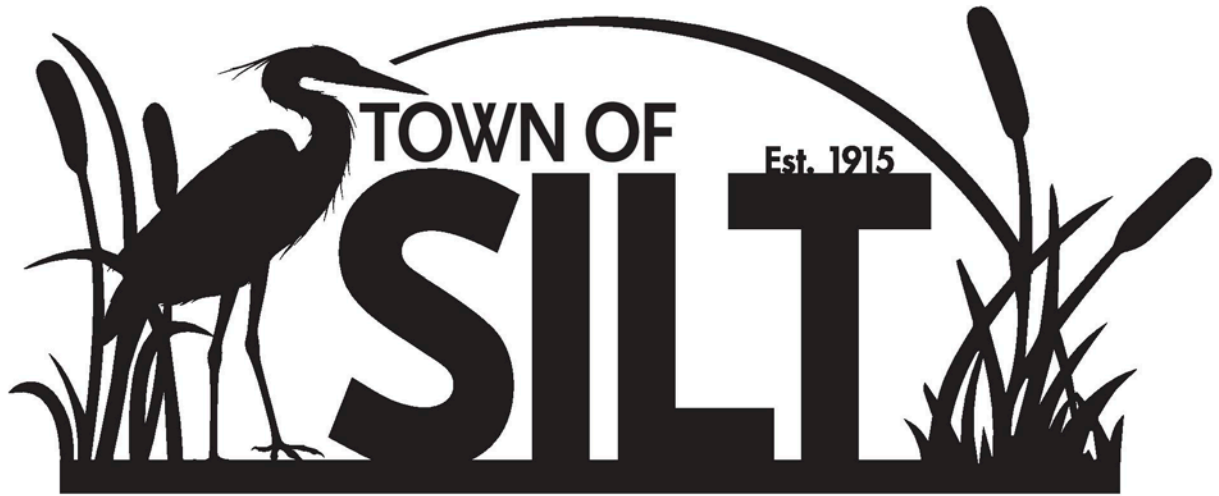
