AGENDA ITEM SUMMARY

SUBJECT:

Town of Silt Board of Trustees Town Manager Finalists Review

PROCEDURE:

The purpose of this meeting is to interview the finalists for the position of Town Manager, review each candidate individually and by name in Executive Session and then, in open session, determine which of them, if any, will move forward in the process. Moving forward may mean instructing staff and the Town Attorney to negotiate an employment contract, arranging for additional interviews, background source interviews, etc.

BACKGROUND OF SUBJECT MATTER:

The Town began advertising for its open Town Manager's position in March 2024 and received 14 resumes. Last month, the Board of Trustees selected five finalists, based on a review of resumes and cover letters, for the position of Town Manager.

SUMMARY:

At the end of this meeting, each candidate will have had the opportunity to meet and discuss their qualifications for this position with members of the Board of Trustees, certain stakeholders of the community and Town of Silt department heads.

Bill Efting and I will lead the Board through the evaluation and decision-making processes. At the end of the meeting, the Board will have elected to go forward with one or more, or no finalists for the position. The Board will further give Town staff directions on how to move forward. This will occur in a public session of the Board.
