**A RESOLUTION SUPPORTING THE GRANT APPLICATION FOR A REVITALIZING MAIN STREETS GRANT IN THE AMOUNT OF \$346,500.00, FOR A TOTAL PROJECT COST OF \$495,000.00, IN ORDER TO OFFSET THE COSTS ASSOCIATED WITH DESIGNING AND CONSTRUCTION OF SIDEWALK, CURB AND GUTTER ON THE 500 BLOCK OF MAIN STREET WITHIN THE TOWN OF SILT, GARFIELD COUNTY, STATE OF COLORADO**

**WHEREAS**, the Town of Silt ("Town") is a municipal corporation, i.e., political subdivision, of the State of Colorado, and therefore is an eligible applicant for a Revitalizing Main Streets Grant awarded by Colorado Department of Transportation.

**WHEREAS**, the Town has submitted a Revitalizing Main Streets Application for the Town of Silt 500 block of Main Street Project, requesting an award of \$346,500.00 from Colorado Department of Transportation (CDOT), with an overall budget of \$495,000.00 for such project; and

**WHEREAS**, the Revitalizing Main Streets Grant would allow for the Town to design and construct sidewalk, curb, gutter and on street parking in the 500 block of Main Street; and

**WHEREAS**, the Town believes that the timing of this design and engineering project is critical to the safety of the Town's citizens, visitors, and businesses, as the project will provide sidewalk and parking to Town businesses; and

**WHEREAS**, the Board recognizes that such grant would help relieve the general fund of the cost of such improvements, as the Town has historically struggled with lack of sales tax and property tax to design and engineer for such improvements; and

**WHEREAS**, the Town Board of Trustees ("Board") supports staff in its grant application for the Revitalizing Main Streets Grant and if funded, ensures that such project will be complete as per the grant guidelines, which includes negotiation of an intergovernmental agreement and submittal of associated documents.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF SILT COLORADO, that:**

**Section 1**


- 1) The above recitals are hereby incorporated as findings by the Town of Silt;
- 2) The Board strongly supports the Revitalizing Main Streets Grant application in the total amount of \$495,000.00, with a contribution from the Town's general fund in the amount of \$148,500.00 for the 500 block of Main Street Improvement Project;
- 3) If the grant is awarded, the Board strongly supports the completion 500 block of Main Street Improvement Project;
- 4) The Board authorizes the expenditure of in-kind labor and budget funds necessary to meet the terms and obligations of any grant awarded pursuant to a Grant Agreement/Intergovernmental Agreement with the Revitalizing Main Streets grant for completion of the project; and
- 5) If a grant is awarded, the Board hereby authorizes Town Administrator Jeff Layman to sign the Revitalizing Main Streets Agreement/Intergovernmental Agreement with the Colorado Department of Transportation.

**Section 2**

This resolution will be in full force and effect from and after its passage and approval.
